A JOINT RESOLUTION

- 1 proposing a constitutional amendment authorizing the legislature
- 2 to provide for an exemption from ad valorem taxation of all or part
- 3 of the market value of the residence homestead of the surviving
- 4 spouse of a 100 percent or totally disabled veteran who died before
- 5 the law authorizing a residence homestead exemption for such a
- 6 veteran took effect.
- 7 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 1-b(j), Article VIII, Texas
- 9 Constitution, is amended to read as follows:
- 10 (j) The legislature by general law may provide that the
- 11 surviving spouse of a 100 percent or totally disabled veteran who
- 12 qualified for an exemption in accordance with Subsection (i) of
- 13 this section from ad valorem taxation of all or part of the market
- 14 value of the disabled veteran's residence homestead when the
- 15 disabled veteran died, or of a 100 percent or totally disabled
- 16 veteran who would have qualified for an exemption from ad valorem
- 17 taxation of all or part of the market value of the disabled
- 18 <u>veteran's residence homestead if that subsection had been in effect</u>
- 19 on the date the disabled veteran died, is entitled to an exemption
- 20 from ad valorem taxation of the same portion of the market value of
- 21 the same property to which the disabled veteran's exemption
- 22 applied, or to which the disabled veteran's exemption would have
- 23 applied if the exemption had been authorized on the date the
- 24 disabled veteran died, if:

- 1 (1) the surviving spouse has not remarried since the
- 2 death of the disabled veteran; and
- 3 (2) the property:
- 4 (A) was the residence homestead of the surviving
- 5 spouse when the disabled veteran died; and
- 6 (B) remains the residence homestead of the
- 7 surviving spouse.
- 8 SECTION 2. The following temporary provision is added to
- 9 the Texas Constitution:
- 10 TEMPORARY PROVISION. (a) This temporary provision applies
- 11 to the constitutional amendment proposed by the 83rd Legislature,
- 12 Regular Session, 2013, authorizing the legislature to exempt from
- 13 ad valorem taxation all or part of the market value of the residence
- 14 homestead of certain surviving spouses of 100 percent or totally
- 15 <u>disabled veterans.</u>
- (b) The amendment to Section 1-b(j), Article VIII, of this
- 17 constitution takes effect January 1, 2014, and applies only to ad
- 18 valorem taxes imposed for a tax year beginning on or after that
- 19 date.
- 20 (c) This temporary provision expires January 1, 2015.
- 21 SECTION 3. This proposed constitutional amendment shall be
- 22 submitted to the voters at an election to be held November 5, 2013.
- 23 The ballot shall be printed to permit voting for or against the
- 24 proposition: "The constitutional amendment authorizing the
- 25 legislature to provide for an exemption from ad valorem taxation of
- 26 all or part of the market value of the residence homestead of the
- 27 surviving spouse of a 100 percent or totally disabled veteran who

- 1 died before the law authorizing a residence homestead exemption for
- 2 such a veteran took effect."
