## A JOINT RESOLUTION

- 1 proposing a constitutional amendment authorizing the legislature
- 2 to provide for an exemption from ad valorem taxation of all or part
- 3 of the market value of the residence homestead of the surviving
- 4 spouse of a member of the armed services of the United States who
- 5 dies while on active duty.
- 6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 1-b, Article VIII, Texas Constitution,
- 8 is amended by adding Subsections (1) and (m) to read as follows:
- 9 (1) The legislature by general law may provide that the
- 10 surviving spouse of an individual who dies while on active duty as a
- 11 member of the armed services of the United States is entitled to an
- 12 exemption from ad valorem taxation of all or part of the market
- 13 value of the surviving spouse's residence homestead if:
- 14 (1) the surviving spouse has not remarried since the
- 15 death of the member of the armed services; and
- 16 (2) the property was the residence homestead of the
- 17 member of the armed services when the member died.
- 18 <u>(m) The legislature by general law may provide that if a</u>
- 19 surviving spouse who qualifies for an exemption in accordance with
- 20 Subsection (1) of this section subsequently qualifies a different
- 21 property as the surviving spouse's residence homestead, the
- 22 <u>surviving spouse is entitled to an exemption from ad valorem</u>
- 23 <u>taxation of the subsequently qualified homestead in an amount equal</u>
- 24 to the dollar amount of the exemption from ad valorem taxation of

- 1 the former homestead in accordance with Subsection (1) of this
- 2 section in the last year in which the surviving spouse received an
- 3 exemption in accordance with that subsection for that homestead if
- 4 the surviving spouse has not remarried since the death of the member
- 5 of the armed services.
- 6 SECTION 2. The following temporary provision is added to
- 7 the Texas Constitution:
- 8 <u>TEMPORARY PROVISION</u>. (a) This temporary provision applies
- 9 to the constitutional amendment proposed by the 83rd Legislature,
- 10 Regular Session, 2013, authorizing the legislature to provide for
- 11 an exemption from ad valorem taxation of all or part of the market
- 12 value of the residence homestead of the surviving spouse of a member
- 13 of the armed services of the United States who dies while on active
- 14 duty.
- 15 (b) Sections 1-b(l) and (m), Article VIII, of this
- 16 constitution take effect January 1, 2014, and apply only to a tax
- 17 year beginning on or after that date.
- 18 (c) This temporary provision expires January 1, 2015.
- 19 SECTION 3. This proposed constitutional amendment shall be
- 20 submitted to the voters at an election to be held November 5, 2013.
- 21 The ballot shall be printed to permit voting for or against the
- 22 proposition: "The constitutional amendment authorizing the
- 23 legislature to provide for an exemption from ad valorem taxation of
- 24 all or part of the market value of the residence homestead of the
- 25 surviving spouse of a member of the armed services of the United
- 26 States who dies while on active duty."
