6	ARTICLE 1. GENERAL PROVISIONS
7	SECTION 1.01. PURPOSE. This resolution is adopted by the
8	members of the House of Representatives of the <u>83rd</u> [82nd]
9	Legislature to provide for the efficient and orderly operation of
10	the house under the supervision of the speaker and the Committee on
11	House Administration.
12	SECTION 1.02. PRECEDENCE. The provisions of this
13	resolution take precedence over the provisions of any resolution
14	not passed in full compliance with the rules of the house and,
15	except as otherwise noted herein, shall be in effect during the full
16	term of the <u>83rd</u> [82nd] Legislature whether in session or
17	adjournment.
18	ARTICLE 2. SPEAKER OF THE HOUSE
19	SECTION 2.01. SPEAKER'S GENERAL POWERS AND DUTIES. The
20	speaker may make any expenditures or transfers and perform any
21	function deemed necessary for the effective and efficient operation
22	of the house of representatives.
23	SECTION 2.02. SPEAKER'S APARTMENT AND OFFICES. (a) The
24	speaker's apartment and offices shall be set aside for the use of
25	the speaker, the speaker's family, and house members, as the
26	speaker may designate, throughout the speaker's term of office.
27	(b) The Committee on House Administration may make the

- 1 necessary expenditures to operate and properly equip and service
- 2 the speaker's apartment and offices and may employ such help as may
- 3 be necessary to properly maintain and care for the apartment and
- 4 offices.
- 5 (c) The speaker and the speaker's family may occupy the
- 6 speaker's apartment during the speaker's term of office, utilizing
- 7 the services of employees of the house and others on a temporary
- 8 basis, if and as needed.
- 9 (d) The speaker may obtain through the Committee on House
- 10 Administration the necessary supplies and services to operate the
- 11 speaker's office and may also have paid through that committee
- 12 necessary local and long distance telephone charges.
- 13 SECTION 2.03. INTERSTATE OR FEDERAL-STATE ASSOCIATIONS;
- 14 TRAINING SEMINARS. (a) The speaker may attend any meetings of or
- 15 sponsored by the Council of State Governments and any meetings on
- 16 problems of federal-state relations and interstate relations and
- 17 cooperation, and any other governmental meeting in or outside the
- 18 state.
- 19 (b) The speaker may appoint members of the house, staff
- 20 members, and other employees of the house to accompany or represent
- 21 the speaker at these meetings or to attend in-service training
- 22 courses sponsored by the Council of State Governments or the
- 23 National Conference of State Legislatures or similar training
- 24 courses, conferences, or seminars as the speaker may determine.
- 25 (c) Members of the house attending meetings under this
- 26 section while the legislature is in session may be reimbursed for
- 27 actual and necessary expenses. Members of the house attending

- 1 meetings under this section while the legislature is not in session and staff members and other employees of the house attending 2 3 meetings at any time under this section may be reimbursed for either actual and necessary expenses or receive a per diem not to exceed 4 5 that provided by law for state officials or state employees. addition, members, staff, and other employees attending meetings 6 under this section may be reimbursed for mileage or 7 8 transportation expenses at the same rate as provided by law for state officials or state employees together with registration fees 9 10 and tuition. To receive payment under this subsection, sworn expense accounts must be filed with and approved by the chair of the 11 Committee on House Administration or an officer of the house 12 designated in writing by the Committee on House Administration. 13 14 Prior written approval of the chair of the Committee on House 15 Administration to attend any such meetings, conferences, seminars, or training courses is a prerequisite for reimbursement for travel 16 17 and other related expenses.
- (d) Reimbursement for expenses incurred by a member, staff member, or employee of the house in an appointive capacity resulting from an appointment made by anyone other than the speaker shall be made only in the event that the appointment and expenses to be incurred have been previously approved in writing by the Committee on House Administration.
- (e) The speaker may expend money for memberships in interstate associations of legislators considered necessary to discharge properly the duties and responsibilities of the office of speaker.

1 ARTICLE 3. GENERAL POWERS AND DUTIES OF THE

- 2 COMMITTEE ON HOUSE ADMINISTRATION
- 3 SECTION 3.01. CONTRACTS. The Committee on House
- 4 Administration shall approve all contracts necessary for the
- 5 effective operation of the divisions of the house and its
- 6 committees.
- 7 SECTION 3.02. HOUSE AND COMMITTEE OPERATING BUDGETS. The
- 8 Committee on House Administration shall consider and adopt
- 9 operating budgets that cover both session and interim periods for
- 10 the divisions of the house and all committees appointed pursuant to
- 11 the resolution adopting the rules of the house or appointed by the
- 12 speaker pursuant to any other resolution.
- 13 SECTION 3.03. OPERATING POLICIES. The Committee on House
- 14 Administration shall effectuate policies and determine guidelines
- 15 for the operation of the divisions and committees of the house.
- 16 SECTION 3.04. HOUSE POLICY MANUAL. The Committee on House
- 17 Administration shall prepare and distribute to all members, within
- 18 60 days after the convening of the regular session, policy
- 19 statements to include, but not be limited to, policies pertaining
- 20 to members as a class.
- 21 SECTION 3.05. HOUSE PROPERTY, SUPPLIES, ACCOUNTING. The
- 22 Committee on House Administration shall:
- 23 (1) provide and maintain for the use of the speaker,
- 24 members, employees, divisions, and committees of the house such
- 25 stationery, stamps, office equipment, furniture, fixtures,
- 26 supplies, and telephone and other services as may be necessary;
- 27 (2) keep an itemized account of the quantity and cost

- 1 of every kind of material received, and the source from which it was
- 2 received;
- 3 (3) maintain an annual operating account for each
- 4 member, division, and committee authorized by the Committee on
- 5 House Administration to make expenditures and charge each operating
- 6 account with daily expenditures, withdrawals from inventory, and
- 7 interdepartmental services;
- 8 (4) furnish a monthly statement for the expenditures
- 9 of each member, division, and committee of the house; and
- 10 (5) adopt any rules, regulations, and policies
- 11 necessary to effectively provide and account for the
- 12 above-mentioned services.
- 13 SECTION 3.06. USE OF HOUSE CHAMBER AND FACILITIES;
- 14 ASSIGNMENT OF DESKS, OFFICES, AND PARKING SPACES. (a) The
- 15 Committee on House Administration shall:
- 16 (1) be in charge of and provide for the protection,
- 17 maintenance, and use of the hall of the house, all committee rooms,
- 18 offices of members and house departments, the speaker's office and
- 19 apartment, and other space under the jurisdiction of the house;
- 20 (2) make permanent assignments of desks and offices to
- 21 members of the house;
- 22 (3) adopt and enforce a plan for the parking of motor
- 23 vehicles on the portion of the Capitol grounds under house
- 24 jurisdiction;
- 25 (4) be in charge of and provide for the protection,
- 26 maintenance, and use of the furniture, fixtures, equipment, and
- 27 records of the house;

- 1 (5) purchase, remodel, repair, restore, or replace any
- 2 furniture, fixtures, equipment, and other furnishings to maintain
- 3 the dignity and appearance of space occupied by the house; and
- 4 (6) determine the hours the hall of the house shall be
- 5 open to visitors.
- 6 (b) Any member who is not a member-elect of the <u>84th</u> [83rd]
- 7 Legislature shall vacate the member's office space before December
- 8 1, 2014 [$\frac{2012}{}$]. If the office is not vacated on that date, the
- 9 Committee on House Administration shall immediately remove the
- 10 member's personal effects and store them in an appropriate place in
- 11 order that the member-elect to whom the office space is assigned may
- 12 move in. The Committee on House Administration shall ensure that
- 13 each member-elect of the $\underline{84th}$ [$\underline{83rd}$] Legislature who was not a
- 14 member of the 83rd [82nd] Legislature is permitted to move into and
- 15 begin using the member-elect's office space at least 72 hours
- 16 before the time the 84th [83rd] Legislature is scheduled to
- 17 convene.
- 18 SECTION 3.07. RECORDS OF THE HOUSE; PRINTING; JOURNALS;
- 19 COPIES OF LEGISLATIVE DOCUMENTS. (a) The Committee on House
- 20 Administration shall:
- 21 (1) have completed and preserved the official records
- 22 of the house;
- 23 (2) have charge of and approve the operation and
- 24 maintenance of the printing and duplicating facilities of the
- 25 house, provided, however, that the use of the house printing and
- 26 duplicating facilities is restricted to agencies of the legislative
- 27 branch and any other operation thereof is strictly prohibited

- 1 unless previously authorized in writing by the Committee on House
- 2 Administration or an officer of the house designated in writing by
- 3 the speaker;
- 4 (3) determine the number of copies of the daily House
- 5 Journal to be printed and have jurisdiction over the mailing and
- 6 distribution of the daily journal; and
- 7 (4) determine the number of copies of the House
- 8 Journal that will be furnished to each member for distribution by
- 9 the member.
- 10 (b) The employee in charge of the printing facilities must
- 11 keep at least one copy of all items printed or duplicated and a copy
- 12 of the work order authorizing such printing.
- 13 (c) Copies of bills, resolutions, and attachments thereto
- 14 shall be made available free of charge to members of the house who
- 15 call at the bill distribution office and request them, and the cost
- 16 of these copies shall be paid from funds appropriated for that
- 17 purpose by the legislature. If the Committee on House
- 18 Administration finds gross abuse of this privilege, it may
- 19 establish a policy regarding such distribution.
- 20 SECTION 3.08. HONORARY CERTIFICATES. The Committee on
- 21 House Administration shall provide for the use of members
- 22 appropriate certificates to commend, congratulate, and
- 23 memorialize. Such certificates shall be printed with a signature
- 24 line for the name of the presenting member and adequate space for
- 25 insertion of the name of the individual or organization to be
- 26 honored.
- 27 SECTION 3.09. COMPOSITE PHOTOGRAPH. (a) The Committee on

- 1 House Administration shall select a suitable photographer to take
- 2 individual photographs of each member. The photographer shall
- 3 prepare a composite photograph of the members of the house composed
- 4 of the individual photographs of each member arranged on a panel, of
- 5 the same size as used in previous sessions, in such manner as to
- 6 approximate the location of each member's desk on the house floor.
- 7 The member's name and the county of residence shall be printed under
- 8 the member's photograph, and the composite shall be framed and hung
- 9 in the hall of the house during the regular session.
- 10 (b) The photographs for the composite panel shall be
- 11 provided without cost to the members, and the expense of the
- 12 composite panel shall be paid from the expense fund of the house.
- 13 (c) The Committee on House Administration shall establish,
- 14 with concurrence of the photographer, a price to charge members for
- 15 any prints of photographs they wish to purchase.
- 16 SECTION 3.10. POLICIES REGARDING TEMPORARY ACTING MEMBERS.
- 17 If a person is serving as a temporary acting member of the house
- 18 under Section 72, Article XVI, Texas Constitution, in the place of a
- 19 house member on active military duty, the Committee on House
- 20 Administration, with the approval of the speaker and in
- 21 consultation with the temporary acting member and, if available,
- 22 the member on military duty, may adopt policies regarding a
- 23 temporary acting member that the committee considers necessary for
- 24 the efficient administration and performance of the duties of the
- 25 house consistent with this resolution, the rules of the house, and
- 26 the Texas Constitution.
- 27 SECTION 3.11. DISPLAY OF "IN GOD WE TRUST" IN HOUSE. (a)

- 1 The Committee on House Administration shall display the motto "In
- 2 God We Trust" on the electronic message screen at the front of the
- 3 hall of the house.
- 4 (b) The motto shall be large enough to be read throughout
- 5 the hall.
- 6 (c) The motto shall be displayed at all times that the
- 7 electronic message screen is not being used to conduct legislative
- 8 business during a session of the house and shall be at least as
- 9 prominent as any other information displayed on the electronic
- 10 message screen.
- 11 (d) The Committee on House Administration shall convey to
- 12 the State Preservation Board the desire of the house of
- 13 representatives to maintain the permanent display of the motto on
- 14 the face of the portico located over the speaker's podium.
- 15 SECTION 3.12. HOUSE RECYCLING PROGRAM. The Committee on
- 16 House Administration, in coordination with the State Preservation
- 17 Board, shall implement a program for recycling paper, plastic, and
- 18 other recyclable materials from house offices.
- 19 ARTICLE 4. EMPLOYEES AND EMPLOYMENT POLICIES
- 20 SECTION 4.01. DEFINITION. Unless expressly provided
- 21 otherwise, in this article "employee" means any person compensated
- 22 from funds appropriated to the house. The term includes persons for
- 23 whom the employing authority is the speaker, the Committee on House
- 24 Administration, an individual member, or a committee.
- 25 SECTION 4.02. OFFICERS AND SUPERVISORY ADMINISTRATIVE
- 26 EMPLOYEES OF THE HOUSE. (a) The officers of the house and the
- 27 employees of the house responsible for supervising the departments

- 1 and divisions that support the operation of the house shall be
- 2 appointed by and serve at the pleasure of the speaker.
- 3 (b) The speaker shall have the right to discharge any
- 4 officer or supervisory administrative employee when the best
- 5 interest of the house of representatives would be served by so
- 6 doing.
- 7 (c) The authority to appoint and discharge officers and
- 8 supervisory administrative employees may be delegated to the
- 9 Committee on House Administration to the extent and for the length
- 10 of time the speaker determines.
- 11 (d) In the event of the absence, resignation, or death of
- 12 any officer or supervisory administrative employee the speaker may
- 13 designate a person to take charge of and attend to all the duties of
- 14 the office affected until the officer or employee returns or until a
- 15 successor is chosen.
- 16 SECTION 4.03. OTHER CENTRAL HOUSE PERSONNEL. (a) The
- 17 Committee on House Administration shall employ all personnel
- 18 necessary for the operation of the house other than:
- 19 (1) those appointed under Section 4.02; or
- 20 (2) employees of an individual member or committee.
- 21 (b) For purposes of this article, the Committee on House
- 22 Administration is the employing authority for all house employees
- 23 other than those for whom the employing authority is the speaker, an
- 24 individual member, or a committee.
- 25 SECTION 4.04. EMPLOYEES OF INDIVIDUAL MEMBER. A member may
- 26 employ, with funds from the member's operating budget, such staff
- 27 as the member deems necessary.

- 1 SECTION 4.05. COMMITTEE STAFF; AUTHORITY TO REQUEST
- 2 ASSISTANCE. (a) The Committee on House Administration shall
- 3 provide funds for the adequate staffing of all standing committees
- 4 of the house and all other committees appointed by the speaker.
- 5 (b) Select committees, interim study committees, standing
- 6 committees, or subcommittees appointed pursuant to the resolution
- 7 adopting the rules of the house or appointed by the speaker pursuant
- 8 to any other resolution may employ any person, firm, or
- 9 corporation, subject to budget limitations. Those committees or
- 10 subcommittees may ask for the assistance of any of the employees,
- 11 agencies, departments, or branches of the state government.
- 12 SECTION 4.06. WORK SCHEDULE; HOURS OF HOUSE OPERATIONS.
- 13 (a) An employee shall be on duty on the days and hours determined by
- 14 the employing authority.
- 15 (b) All offices of the departments and divisions that
- 16 support the operations of the house shall be open on days and hours
- 17 determined by the Committee on House Administration or the speaker
- 18 and other hours that the house or its committees are in session.
- 19 SECTION 4.07. COMPENSATION. (a) Officers and supervisory
- 20 administrative employees of the house shall receive the
- 21 compensation that the speaker or Committee on House Administration
- 22 determines.
- 23 (b) The Committee on House Administration shall fix the
- 24 compensation of house personnel employed under Section 4.03. A
- 25 person employed under that section who is absent without leave
- 26 shall not receive compensation for the time missed.
- 27 (c) The salaries of employees of individual members,

- 1 committees, and the house shall begin when they are instructed to
- 2 start work by their respective employing authority.
- 3 (d) Except as provided by Subsections (e) and (f) of this
- 4 section, an employee of an individual member, a committee
- 5 employee, or any person, firm, or corporation employed by a
- 6 committee or subcommittee may not be paid a salary in excess of
- 8 (e) A member may exempt one employee of the individual
- 9 member and, if the member is a chair of a standing or select
- 10 committee, one employee of the standing or select committee the
- 11 member chairs from the salary cap imposed by Subsection (d) of this
- 12 section. Each calendar year the member shall file with the
- 13 Committee on House Administration a statement designating the
- 14 exempt employee or employees, as appropriate. During a calendar
- 15 year after an exempt employee has been designated, the member may
- 16 exempt a different employee from the salary cap only if the employee
- 17 previously designated as exempt for the calendar year is no longer
- 18 employed by the member or committee, as appropriate. The exempt
- 19 employee may not receive compensation from the operating account of
- 20 any other committee or member.
- 21 (f) The Committee on House Administration may increase the
- 22 amount of the salary cap imposed by Subsection (d) of this section
- 23 to account for any increase in salary provided to all state
- 24 employees during the biennium that begins during the term of the
- 25 legislature to which this resolution applies.
- 26 SECTION 4.08. DUTIES. An employee shall perform all duties
- 27 directed by the employing authority.

- 1 SECTION 4.09. APPEARANCE BEFORE COMMITTEES. An employee
- 2 may appear before a standing or select committee on a measure when
- 3 granted permission by majority vote of the committee.
- 4 SECTION 4.10. CHAMBER ACCESS. (a) An employee may not
- 5 enter the house chamber when the house is in session except when
- 6 performing official duties and specifically authorized by the
- 7 Committee on House Administration.
- 8 (b) An employee may not enter the area on the floor of the
- 9 house enclosed by the railing when the house is in session except
- 10 when specifically authorized by the Committee on House
- 11 Administration.
- 12 SECTION 4.11. VOTING. An employee may not cast a vote for a
- 13 member on the voting machine or otherwise.
- 14 SECTION 4.12. VOTING RECORDS. An employee may not compile
- 15 or release any information concerning the voting record of any
- 16 member of the house for any session of the legislature except when a
- 17 member requests information about that member's personal voting
- 18 record or when the information is for the journal or other official
- 19 records.
- 20 SECTION 4.13. CAMPAIGN FOR SPEAKER. An employee may not
- 21 campaign or assist in the campaign of any candidate for speaker.
- 22 SECTION 4.14. POLITICAL INFLUENCE. An employee may not
- 23 attempt to, or aid anyone in an attempt to, influence any member of
- 24 the house in favor of or against any measure pending before the
- 25 legislature, either directly or indirectly, except when answering
- 26 questions or giving information at the request of a member of the
- 27 house.

- 1 SECTION 4.15. OUTSIDE EMPLOYMENT, EXTRA COMPENSATION, OR
- 2 GIFTS. An employee may not receive, directly or indirectly, any
- 3 compensation, by gift or otherwise, from any other source, unless
- 4 specifically authorized by the employing authority.

- 10 identified legislators as members of the organization, and that
- 11 exists for research and other support of policy development and
- 12 interests that the membership holds in common. An organization
- 13 whose only nonlegislator members are the lieutenant governor or the
- 14 governor remains a "caucus" for purposes of this section.
- 15 SECTION 6.02. USE OF HOUSE FUNDS, EMPLOYEES, EQUIPMENT, AND
- 16 FACILITIES. (a) Except as expressly authorized by this section,
- 17 funds appropriated to the house may not be expended in support of a
- 18 caucus, employees compensated from funds appropriated to the house
- 19 may not perform caucus activities, and state-owned equipment may
- 20 not be used in the performance of caucus activities.
- 21 (b) An individual member of the house may authorize the use
- 22 of state equipment assigned to the member's office and the
- 23 performance of caucus activities by an employee of the member only

- 5 (c) A caucus may use the meeting rooms of the Capitol and
- 6 Capitol extension to conduct meetings of the caucus membership, to
- 7 host public forums on matters of interest to the caucus, or to
- 8 facilitate the work of the caucus or a caucus employee.
- 9 (d) An individual member may house, in the state office
- 10 space assigned to the member, caucus employees or equipment owned
- 11 by a caucus. A member may retain in the member's office a
- 12 telephone, facsimile machine, or computer owned by the caucus for
- 13 purposes of the member's communication with the caucus or caucus
- 14 employees.
- 15 (e) From space under the jurisdiction of the house, the
- 16 Committee on House Administration may assign:
- 17 (1) one office space and one parking space for use by
- 18 the Texas Republican Legislative Caucus; and
- 19 (2) one office space and one parking space for use by
- 20 the House Democratic Caucus.
- 21 SECTION 6.03. CONTRIBUTIONS. (a) A person acting on behalf
- 22 of a caucus may not knowingly accept a contribution in violation of
- 23 Section 253.0341, Election Code.
- 24 (b) A person acting on behalf of a caucus may not knowingly
- 25 accept a contribution, and shall refuse a contribution that is
- 26 received, in the Capitol.
- 27 SECTION 6.04. MEMBERSHIP AND OFFICER LISTS. Each caucus

- 1 shall provide to the chief clerk, on a regular basis, a list of its
- 2 current membership and officers.
- 3 SECTION 6.05. REPORT TO ETHICS COMMISSION. Each caucus
- 4 shall file a report of contributions and expenditures with the
- 5 Texas Ethics Commission as required by Section 254.0311, Election
- 6 Code.
- 7 ARTICLE 7. HOUSE RESEARCH ORGANIZATION
- 8 SECTION 7.01. ESTABLISHMENT. The Committee on House
- 9 Administration shall provide operating funds for a house research
- 10 organization that will be an administrative department of the house
- 11 and may for that purpose adopt policies and procedures relating to
- 12 the administrative operation of that organization.
- 13 SECTION 7.02. STEERING COMMITTEE. The functions and duties
- 14 performed by the house research organization shall be governed by a
- 15 15-member steering committee composed of house members serving
- 16 staggered four-year terms, who are subject to approval of the house

- 22 ARTICLE 8. SPECIAL PROVISIONS FOR INTERIM
- 23 SECTION 8.01. INTERIM COMMITTEE ACTIVITIES. (a) Pursuant
- 24 to the Legislative Reorganization Act of 1961 (Subchapter B,
- 25 Chapter 301, Government Code), standing committees of the house
- 26 established by the rules of the house may hold meetings while the
- 27 legislature is not in session.

- 1 (b) The speaker may grant authority to select committees, interim study committees, subcommittees, or standing committees of 2 3 the house to hold meetings while the legislature is not in session as the speaker considers necessary and desirable to conduct the 4 5 business of the house and to assist the speaker in conducting the business of the house, under a pattern of 6 operation restrictions determined by the rules of the house. 7
- 8 (c) The committee members and employees may either be
 9 reimbursed for actual and necessary expenses or receive a per diem
 10 not to exceed that provided by law for state officials or state
 11 employees, along with mileage or other transportation expenses at
 12 the same rate as provided by law for state officials or state
 13 employees when conducting such business and attending those
 14 meetings when approved by the Committee on House Administration.
- SECTION 8.02. POWERS AND DUTIES OF COMMITTEE ON HOUSE
 ADMINISTRATION DURING INTERIM. (a) When the legislature is not in
 session, the Committee on House Administration may act as provided
 by this section.
- The committee may call meetings for the transaction of 19 necessary business, and the committee members shall be reimbursed 20 for expenses incurred by them when attending such meetings or when 21 in performance of their duties as members of the Committee on House 22 23 Administration, the reimbursement to be either actual and necessary 24 expenses or a per diem not to exceed that provided by law for state officials or state employees, along with mileage or other 25 26 transportation expenses at the same rate as provided by law for 27 state officials or state employees.

- (c) The committee may reimburse authorized members and 1 2 employees for expenses incurred by them when traveling in the 3 performance of their legislative duties and responsibilities within their respective districts or within any county in which any 4 part of their districts lie or from their districts to the State 5 Capitol, the reimbursement to be either actual and necessary 6 expenses or a per diem not to exceed that provided by law for state 7 8 officials or state employees, along with mileage or transportation expenses at the same rate as provided by law for 9 10 state officials or state employees.
- (d) The committee may pay for all other reasonable and 11 necessary expenses, including operation of each member's district 12 office, incurred by the members of the house of representatives. 13 14 The expenses shall be paid from funds appropriated for that purpose, or any other funds appropriated for the use of the house of 15 representatives, on vouchers or other forms approved by the chair 16 17 of the Committee on House Administration, in accordance with regulations governing such expenditures. 18
- 19 (e) The committee may assign or reassign parking places in 20 the best interest of the house under such terms and conditions as 21 the committee deems necessary.
