

R E S O L U T I O N

1 WHEREAS, A rich and purposeful life drew to a close with the
2 death of James L. Bearden of Arlington on November 9, 2011, at the
3 age of 60; and

4 WHEREAS, Born in Dallas on August 20, 1951, Mr. Bearden was
5 the son of Clarence Wesley Bearden and Wanda Fae Bedwell Bearden;
6 and

7 WHEREAS, James Bearden served as an intelligence officer in
8 the military and subsequently built a career as a private
9 investigator and security expert; along the way, he earned a
10 bachelor's degree in political science from The University of Texas
11 at Arlington and then continued his education at the Texas Wesleyan
12 School of Law, where he earned a degree in 2001; he went on to enter
13 private practice and to serve as General Counsel for the Texas
14 Association of Licensed Investigators; and

15 WHEREAS, Involved in his community, Mr. Bearden variously
16 shared his time and talents as an assistant scoutmaster, as
17 president of the Fielder Museum, and as a member of the UTA Alumni
18 Association Board of Directors; moreover, he was a valued
19 congregant of St. Vincent de Paul Catholic Church; and

20 WHEREAS, In the early 1970s, Mr. Bearden married Shana Lesa
21 Bearden, and the couple shared 37 years together, until her death in
22 2009; they were blessed with four children, Wes, Brad, April, and
23 Chrissy, and their family later grew to include three
24 grandchildren, Lily, Bella, and Maddie; and

1 WHEREAS, Deeply devoted to his family and his community,
2 James Bearden made a meaningful difference in the lives of his loved
3 ones and fellow citizens alike, and he leaves behind a legacy that
4 will be treasured for years to come; now, therefore, be it

5 RESOLVED, That the House of Representatives of the 83rd Texas
6 Legislature hereby pay tribute to the life of James L. Bearden and
7 extend sincere condolences to the members of his family: to his
8 sons, Wes Bearden and his wife, Antoinette, and Brad Bearden and his
9 fiancée, Tiffani Brooks; to his daughters, April Flowers and her
10 husband, T. J., and Chrissy Bailey and her husband, Doug; to his
11 grandchildren, Lily and Maddie Flowers and Bella Bearden; to his
12 brother, Dan Bearden, and his wife, Amy; to his sisters, Wanda
13 Burton and Bonnie Sims; and to his other relatives and many friends;
