1 WHEREAS, Althea Lewis Renfro of Houston, an esteemed educator
2 and friend to many, passed away on December 27, 2012, at the age of
3 85; and

4 WHEREAS, Born in Houston on February 10, 1927, to Elijah and
5 Martha Lewis, "AlphaBelle" Lewis attended Bruce Elementary School
6 and Phillis Wheatley High School, where she was active in the Purple
7 and White Squadron and Wheatley's Lovable Troubadours; graduating
8 at the age of 15, she enrolled at Texas Southern University and went
9 on to earn both bachelor's and master's degrees, as well as her
10 teaching certification in chemistry, physical science, general
11 science, homemaking, kindergarten, and elementary education; and

12 WHEREAS, This industrious young woman initially taught in
13 Louisiana before returning to Texas and joining the staff of the
14 Double Bayou School in Anahuac; she subsequently went to work for
15 the Houston Independent School District, and during long tenures at
16 Crawford and Hohl Elementary Schools, Mrs. Renfro served as a
17 positive influence on many young people; admired for her
18 leadership, she chaired the Faculty Advisory Council at Crawford
19 Elementary and was the United Negro College Fund school
20 representative; and

21 WHEREAS, In addition to her professional achievements,
22 Mrs. Renfro served as the pianist for three different churches and
23 directed the Greater Mount Olive Baptist Church senior choir and
24 male chorus; she was a gifted and prolific poet as well who authored

1 more than 300 poems and composed several gospel songs; and

2 WHEREAS, Mrs. Renfro participated in a variety of worthwhile
3 organizations, including Zeta Phi Beta Sorority, the National
4 Teachers Association, the National Education Association, the
5 LaVioleta Social and Charity Club, and the Order of the Eastern
6 Star; she assisted the Red Cross and the Greater Houston Convention
7 and Visitors Bureau as a volunteer, and she established the Ted
8 Taylor Fan Club, a group that sponsored field trips and cultural
9 outings for teens in the Fifth Ward; and

10 WHEREAS, The mother of three children, she was also a devoted
11 mother figure to the children of her two blended families; before
12 becoming the beloved wife of Porter Renfro, Jr., she supported her
13 children in numerous activities, attending countless football
14 games, marching band performances, and Girl Scout campouts; later,
15 she and Mr. Renfro became known as "Mommadear" and "Granddaddy" to
16 their close-knit circle of loved ones; during their 40 years
17 together, the couple traveled extensively and hosted many
18 gatherings in their home; and

19 WHEREAS, Althea Renfro made a meaningful difference in the
20 world around her, and she leaves behind a legacy that will continue
21 to inspire others for years to come; now, therefore, be it

22 RESOLVED, That the House of Representatives of the 83rd Texas
23 Legislature hereby pay tribute to the life of Althea Lewis Renfro
24 and extend sincere condolences to the members of her family: to her
25 children, Algenita Segars and her husband, Ardie, and Jacky Scott
26 and his wife, Cynthia; to her grandchildren, Marthea Davis, Jackea
27 M. Scott, and John W. Davis IV; to her stepchildren, Ronald Bennett
