

R E S O L U T I O N

1           WHEREAS, Members of the National Association of Insurance and  
2 Financial Advisors-Texas (NAIFA-Texas), the Texas Association of  
3 Health Underwriters (TAHU), and the Texas Association of Life and  
4 Health Insurers (TALHI) are gathering in Austin on January 22,  
5 2013, for their joint legislative day at the State Capitol; and

6           WHEREAS, NAIFA-Texas, which was founded in 1925 as the Texas  
7 Association of Life Underwriters, is composed of more than 3,000  
8 members statewide; led by president Douglas Massey, it advocates  
9 for a positive legislative and regulatory environment and aims to  
10 promote ethical conduct and enhance business and professional  
11 skills among its membership; and

12           WHEREAS, TAHU was established in 1985 to represent the  
13 interests of licensed professional health insurance agents,  
14 brokers, consultants, and benefit professionals; now the largest  
15 association of its kind in the state, it benefits from the  
16 leadership of president Kelly Fristoe; its programs are designed to  
17 enhance the professional growth, knowledge, and integrity of its  
18 members, thereby enabling them to better inform and protect the  
19 consumer; and

20           WHEREAS, TALHI was formed in 1997, following the merger of  
21 the Texas Life Insurance Association and the Texas Legal Reserve  
22 Officials Association; under the guidance of chairman Tom Munson,  
23 its mission is to ensure the continued viability of the life and  
24 health insurance industry in Texas; and

1           WHEREAS, These organizations consistently work in behalf of  
2 consumers and businesses to advance financial security and reliable  
3 insurance, and their legislative day provides a fitting opportunity  
4 to recognize the dedicated efforts of their members; now,  
5 therefore, be it

6           RESOLVED, That the House of Representatives of the 83rd Texas  
7 Legislature hereby welcome members of the National Association of  
8 Insurance and Financial Advisors-Texas, the Texas Association of  
9 Health Underwriters, and the Texas Association of Life and Health
