## RESOLUTION

- 1 WHEREAS, Many proud residents of Mansfield are visiting
- 2 Austin on March 6, 2013, to celebrate the distinctive attributes
- 3 and achievements of their community during Mansfield Day at the
- 4 State Capitol; and
- 5 WHEREAS, Located in the Cross Timber country of North Central
- 6 Texas, south of Arlington, the settlement was first established by
- 7 pioneers in the 1840s; in the late 1850s, R. S. Man and Julian Feild
- 8 built a grist mill in the area, at the crossroads that later became
- 9 the center of the town, which was named for the two men; and
- 10 WHEREAS, Mr. Feild soon added a general store across the
- 11 street from the mill and became the town's postmaster in 1860;
- 12 during the Civil War, the Man and Feild gristmill supplied meal and
- 13 flour to fighting soldiers, and it later did the same for those at
- 14 United States Army outposts and Indian reservations in Texas and
- 15 New Mexico; though incorporated in 1909, the town remained a
- 16 farming community until the suburban expansion of the Dallas/Fort
- 17 Worth area brought many new residents; and
- 18 WHEREAS, Today, the city's more than 50,000 residents can
- 19 enjoy 240 acres of parks and a quality of life reflected in the
- 20 town's inclusion on Money magazine's 2012 list of the top places to
- 21 live in the United States; and
- WHEREAS, Mansfield will be led in 2013 by the dedicated
- 23 members of its city council, including mayor David Cook and mayor
- 24 pro tempore Larry Broseh, as well as Brent Newsom, Stephen Lindsey,
