

R E S O L U T I O N

1 WHEREAS, Bobby Teague, a veteran educator and coach, retired
2 from the Brownsboro Independent School District Board of Trustees
3 in December 2012, concluding more than a decade of exemplary
4 service; and

5 WHEREAS, Mr. Teague was first elected to the board in 1999 and
6 has served as president for the past three years; throughout his
7 tenure, he has carried out his duties with skill and dedication, and
8 in so doing, he has helped to guide Brownsboro ISD into an era of
9 academic growth and progress; and

10 WHEREAS, The insight that Mr. Teague brought to the board
11 came from his many decades of experience in education, which began
12 with his work as a classroom teacher at Aransas Pass ISD in 1956; he
13 taught at a number of other institutions throughout the next 12
14 years before accepting a position as an assistant coach with the
15 Brownsboro ISD football program; and

16 WHEREAS, After only a year, Mr. Teague was named head
17 football coach and athletic director; he went on to lead the
18 Brownsboro Bears to a total of 24 wins and 13 losses during his four
19 years of coaching, including an impressive 9-1 season in 1971; in
20 addition, he distinguished himself in other coaching positions,
21 helped establish golf and tennis programs, and oversaw the
22 construction of a new field house; and

23 WHEREAS, Mr. Teague went on to embrace new challenges in 1973
24 when he became the principal of Brownsboro Elementary School; after

1 12 years in that post, he accepted the position of principal of
2 Brownsboro High School, where he served for another 11 years; and

3 WHEREAS, Once retired, Mr. Teague continued to show his love
4 for the game of football as an announcer at Bear Stadium; in all his
5 endeavors, he has enjoyed the love and support of his wife, Myra Jo;
6 and

7 WHEREAS, Through his expertise and unwavering commitment to
8 BISD, Bobby Teague has greatly contributed to the success of many
9 young Texans, and he may take justifiable pride in his myriad
10 achievements in behalf of area schoolchildren; now, therefore, be
11 it

12 RESOLVED, That the House of Representatives of the 83rd Texas
13 Legislature hereby commend Bobby Teague for his many years of
14 leadership as president and as a trustee of the Brownsboro
15 Independent School District and extend to him sincere best wishes
16 for continued happiness; and, be it further

17 RESOLVED, That an official copy of this resolution be
18 prepared for Mr. Teague as an expression of high regard by the Texas
19 House of Representatives.
