- 1 WHEREAS, Residents of Brownsville are gathering in Austin on
- 2 January 29, 2013, to celebrate Brownsville Day at the State
- 3 Capitol; and
- WHEREAS, The site of Brownsville, originally settled under a
- 5 1781 Spanish land grant, was the location of a fortification
- 6 constructed in 1846 by soldiers led by General Zachary Taylor in
- 7 preparation for the coming war with Mexico; named Fort Brown in
- 8 honor of Major Jacob Brown, who died in an attack on the United
- 9 States forces, the area became part of the State of Texas at the
- 10 signing of the Treaty of Guadalupe Hidalgo in 1848; and
- 11 WHEREAS, Brownsville was made county seat of the new Cameron
- 12 County in January 1849, and it soon replaced Matamoros as the
- 13 leading trade center for the area; with the 1850 Census showing
- 14 two-thirds of the residents from the Eastern United States and the
- 15 remainder from Mexico, Ireland, France, England, and Germany, the
- 16 town had already taken on a cosmopolitan and multilingual
- 17 character; and
- 18 WHEREAS, Now the largest city in the Lower Rio Grande Valley
- 19 with more than 175,000 people, Brownsville celebrates its heritage
- 20 as an active gateway between two countries that are joined by
- 21 hundreds of years of tradition, history, and family; and
- WHEREAS, Building on the unique strengths of its population
- 23 and economic assets, the Brownsville community has come together to
- 24 develop the Imagine Brownsville Comprehensive Plan, and the United

- 1 Brownsville Partnership was formed to ensure the implementation of
- 2 the plan; and
- 3 WHEREAS, Members of the partnership are committed to
- 4 maximizing the advantages of their access to a deep-sea port and
- 5 international markets to create a local economy that will drive
- 6 prosperity for the region and this state; they include
- 7 representatives of the City of Brownsville, the Brownsville
- 8 Navigation District, The University of Texas at Brownsville, the
- 9 Brownsville Community Improvement Corporation, Texas Southmost
- 10 College, the Greater Brownsville Improvements Corporation, the
- 11 Brownsville Independent School District, the Brownsville Public
- 12 Utilities Board, the Brownsville Chamber of Commerce, the
- 13 Brownsville Economic Development Council, the Brownsville
- 14 Convention and Visitors Bureau, the Brownsville South Padre Island
- 15 International Airport, the United Way of Southern Cameron County,
- 16 Cameron County, and Workforce Solutions Cameron; and
- WHEREAS, A dynamic community that draws on a rich history as
- 18 it prepares for an exciting future, Brownsville has established
- 19 itself as an outstanding place in which to live and work, and its
- 20 citizens may take great pride in the area's ongoing achievements;
- 21 now, therefore, be it
- 22 RESOLVED, That the House of Representatives of the 83rd Texas
- 23 Legislature hereby recognize January 29, 2013, as Brownsville Day
- 24 at the State Capitol and extend to the visiting delegation sincere
