11 250,000 members in approximately 1,000 chapters across the United

WHEREAS, Among Delta's founders were four women born in 14 Texas, Zephyr Chisom Carter of El Paso, Jessie McGuire Dent of 15 Galveston, Frederica Chase Dodd of Dallas, and Myra Davis Hemmings 16 of Gonzales, and the sorority maintains a strong connection with 17 the Lone Star State today, with 62 Texas chapters; as Delta 18 celebrates its centennial this year, several chapters in the state 19 are concurrently marking 25 and 50 years of service; in addition, 20 21 Dallas has been singled out as one of 22 cities important to the history of the sorority, and it is consequently hosting the passing 22 23 of the Delta Torch, which is crossing the nation as part of the
