- 5 Saint Paul Mission, later changing to East St. Paul Methodist

- 7 sanctuary was destroyed by a fire in 1941, the congregation pulled
- 8 together and rebuilt several years later; in 1974, members gathered
- 9 for the first time at the church's current home on R. L. Thornton
- 10 Freeway; and
- 11 WHEREAS, United by their shared faith and strong traditions,
- 12 the members of this notable house of worship support a variety of
- 13 commendable programs that offer fellowship as well as help to those
- 14 in need; its many outreach ministries include such diverse areas as
- 15 career development, homeless assistance, social action, academic
- 16 skills reinforcement, and physical fitness; and
- WHEREAS, Over the decades, the church has benefited from the
- 18 leadership of many excellent pastors; Rev. Merrell T. Reed led the
- 19 congregation in its earliest years, and Rev. Timothy B. Echols and
- 20 Rev. John W. Tatum, Sr., guided the church's expansion of social
- 21 programs in the mid-1960s to early 1970s; Rev. Zan W. Holmes, Jr.,
- 22 assumed leadership in 1974 and served for 28 years, during which
- 23 time he added "Community" to the church's name to match its civic
- 24 mission and oversaw the development of its Community Life Center,

- 1 named in his honor; the current pastor, Rev. Henry L. Masters, Sr.,
- 2 is nationally known and respected and has served St. Luke since July
- 3 2012; and

- 6 the years, and this notable milestone provides a fitting
- 7 opportunity to recognize all who have contributed to its longevity;
