1           WHEREAS, Continuing its tradition of athletic excellence,  
2 the Throckmorton High School football team won the University  
3 Interscholastic League 1A Six-Man Division 1 state championship on  
4 December 15, 2012; and

5           WHEREAS, The Greyhounds recorded a commanding 72-30 victory  
6 over Abbott High School in the title game, overwhelming their  
7 opponent with a powerful offensive attack that rolled up 506 total  
8 yards; the team's postseason march to the championship also  
9 included dominating performances against Rotan and Water Valley, a  
10 comfortable 30-point win over Rankin, and a hard-fought triumph in  
11 its semifinal showdown with Turkey Valley; and

12           WHEREAS, In capturing the 2012 crown, Throckmorton continued  
13 an impressive run of gridiron success that has spanned three  
14 seasons; during that period, the Greyhounds have compiled 41 wins  
15 against just 2 losses, and they have played in three state  
16 championship games, winning two of them; and
