- 6 his membership in such civic organizations as the Edinburg Chamber
- 7 of Commerce, Amigos del Valle, San Juan Youth Program, Pharr and San
- 8 Juan Boys Club, and the San Juan Lions Club; and
- 9 WHEREAS, In all his endeavors, Mr. Garza enjoyed the support
- 10 of his loving family, and he took great pride in his four children,
- 11 Lizza, Lori, John, and Michael, and his granddaughter, Ava; and

- 13 generous spirit and his outstanding record of public and
