9 River at Doan's Crossing during the great cattle drives; oil,

discovered in the early 20th century, remains important to the 10

11 region's economy; and

12 WHEREAS, County seat Vernon was originally called Eagle Flat for the abundance of nesting eagles nearby; today, the city is a 13 14 center for farming, ranching, and the petroleum industry; the birthplace of rock and roll legend Roy Orbison, the town is also 15 home to Vernon College and the Red River Valley Museum, which 16 chronicles the history, culture, and geography of the region; and 17 18 WHEREAS, Established in 1849, the Waggoner Ranch, south of Vernon, is the largest ranch in Texas under one fence and a 19

five-time winner of the Texas Ranch Roundup; the Santa Rosa 20 21 Palomino Club is a renowned precision equestrian riding club, and the club's annual Santa Rosa Roundup draws thousands of visitors 22 23 and top professional rodeo riders; residents and visitors alike also enjoy the picnic every May at Doan's Crossing, one of the 24
