1           WHEREAS, An esteemed Texan and friend to many, A. J. Cain of  
2 Midland passed away on February 3, 2013, at the age of 84; and

3           WHEREAS, Born in Big Spring on August 31, 1928, to Alice  
4 Haynes Cain and Andrew Jackson Cain, A. J. Cain graduated from Big  
5 Spring High School; he enlisted in the United States Army when he  
6 was all of 17 years old, and after completing his service, he was  
7 honorably discharged in 1948; he subsequently attended Howard  
8 County Junior College and then transferred to the University of  
9 North Texas, where he earned a degree in marketing; a talented  
10 athlete, he played baseball and football and ran track while in high  
11 school and college; and

12           WHEREAS, On September 8, 1951, A. J. Cain exchanged wedding  
13 vows with the former Bonnie Dempsey in Big Spring, and the couple  
14 became the proud parents of two daughters, Chris and Diane; Mr. and  
15 Mrs. Cain enjoyed a loving marriage of 58 years, until her passing  
16 in 2010; and

17           WHEREAS, Mr. Cain's first employment after college was with  
18 the Hughes Tool Company, and during his time with that  
19 organization, he and his family lived in Odessa, Levelland,  
20 Brownfield, and Andrews; in 1956, he accepted a job with Mustang  
21 Mud, beginning a longtime career in the drilling mud business;  
22 Mr. and Mrs. Cain relocated to Midland in 1963 and made that  
23 community their home for the rest of their lives; and

24           WHEREAS, Working with Mustang Mud gave Mr. Cain the chance to

1 meet many people, and his clients often became close friends; aside  
2 from his work, he enjoyed time spent with the downtown morning  
3 coffee group he belonged to, and he was an avid sports fan,  
4 especially loyal to the Dallas Cowboys and Texas Rangers; he also  
5 took great pleasure in art, music, the theater, delicious food, and  
6 good books; and

7       WHEREAS, Mr. Cain attended Trinity Presbyterian Church for  
8 nearly half a century, serving at various times as a ruling elder,  
9 deacon, and trustee and assisting his wife with the youth  
10 fellowship group, accompanying them on mission trips and  
11 excursions; late in life, he joined Grace Presbyterian Church; and

12       WHEREAS, Generous and giving, Mr. Cain helped many young  
13 people to continue their education, offering encouragement and  
14 assistance, and he supported the work of nonprofits and charitable  
15 organizations; he loved to travel with his wife, exploring the  
16 country and the world, and he took up flying in his forties; a  
17 favorite spot to visit was the family cabin in Ruidoso, New Mexico,  
18 where he would hike, ski, entertain friends, and watch and feed the  
19 birds; and

20       WHEREAS, A. J. Cain was a gentle man whose boundless warmth  
21 and zest for life will long be remembered by everyone who had the  
22 privilege of knowing him; now, therefore, be it

23       RESOLVED, That the House of Representatives of the 83rd Texas  
24 Legislature hereby pay tribute to the memory of A. J. Cain and  
25 extend sincere condolences to the members of his family: to his  
26 daughters, Chris Cain Laufer and her husband, Jeff, and Diane Cain
