RESOLUTION

- 1 WHEREAS, In 2013, the Honorable Sam Johnson, a member of the
- 2 United States House of Representatives, commemorated the 40th
- 3 anniversary of his homecoming from Vietnam, where he endured nearly
- 4 seven years as a Prisoner of War; and
- 5 WHEREAS, This highly decorated war hero served his country
- 6 for 29 years as an officer in the U.S. Air Force; raised in Dallas,
- 7 he joined the military at the age of 20, shortly after graduating
- 8 from Southern Methodist University, and completed 62 combat
- 9 missions as a fighter pilot during the Korean War; he subsequently
- 10 flew with the elite Air Force Thunderbirds and directed the Air
- 11 Force Fighter Weapons School; and
- 12 WHEREAS, Congressman Johnson served two tours of duty in
- 13 Vietnam; on April 16, 1966, during his second tour, he was shot down
- 14 over North Vietnam while flying his 25th combat mission; ejecting
- 15 from his plane, he sustained a dislocated shoulder, broken arm, and
- 16 broken back; and
- WHEREAS, After his capture, then Major Sam Johnson was held
- 18 at the notorious "Hanoi Hilton" prison camp, where he survived 72
- 19 days in leg stocks and 2-1/2 years in leg irons, as well as severe
- 20 beatings and starvation; identified by his captors as a "die-hard"
- 21 because of his refusal to cooperate, he was placed in solitary
- 22 confinement for 3-1/2 years; his ordeal finally ended with his
- 23 release from prison on February 12, 1973; he later wrote about his
- 24 experiences as a Prisoner of War in his book Captive Warriors: A

- 1 Vietnam POW's Story, which was published in 1992; and
- WHEREAS, Congressman Johnson retired from the U.S. Air Force
- 3 with the rank of colonel in 1979; among the many military awards he
- 4 received were two Silver Stars, two Legions of Merit, the
- 5 Distinguished Flying Cross, one Bronze Star with Valor, two Purple
- 6 Hearts, four Air Medals, and three Outstanding Unit Awards; and
- WHEREAS, Following his return to civilian life, Congressman
- 8 Johnson established a home-building business and served for seven
- 9 years in the Texas House of Representatives; since 1991, he has
- 10 represented the Third District of Texas in the U.S. Congress, where
- 11 he is a member of the Committee on Ways and Means and the chair of
- 12 the Social Security Subcommittee; a dedicated advocate for the men
- 13 and women in the military, he was named by his peers in 2009 as the
- 14 "most admired" Republican in the U.S. House of Representatives; and
- WHEREAS, In all of his endeavors, Sam Johnson has enjoyed the
- 16 love and support of his wife, Shirley; the couple have been blessed
- 17 with 3 children and 10 grandchildren; and
- 18 WHEREAS, A distinguished patriot, Congressman Johnson
- 19 continues to represent his country with extraordinary honor and
- 20 dedication, and he is truly worthy of special recognition for his
- 21 service; now, therefore, be it
- 22 RESOLVED, That the House of Representatives of the 83rd Texas
- 23 Legislature hereby honor Congressman Sam Johnson on the 40th
- 24 anniversary of his homecoming from Vietnam and extend to him
- 25 sincere appreciation for his deep devotion to this country and to
- 26 the cause of freedom; and, be it further
- 27 RESOLVED, That an official copy of this resolution be

- 1 prepared for Congressman Johnson as an expression of high regard by
- 2 the Texas House of Representatives.
