

R E S O L U T I O N

1           WHEREAS, An exemplary life devoted to family, faith, and  
2 public service came to an untimely end with the death of Tommy Dean  
3 Shearrer of Pleasanton on October 10, 2012, at the age of 56; and

4           WHEREAS, Tommy Shearrer was born to Carl Dean and Beverly  
5 Gail Matthews Shearrer on September 26, 1956; raised on the Perry  
6 Feeder's dairy farm, he attended Pleasanton schools, where he was a  
7 leading member of FFA, serving as the organization's state  
8 president; he went on to attend Southwest Texas State University;  
9 and

10           WHEREAS, In 1977, Mr. Shearrer married his high school  
11 sweetheart, the former Sharon Lynn Yow, and they shared a loving  
12 relationship for 35 years; they were blessed with two sons, Wesley  
13 and Matthew; and

14           WHEREAS, Over the course of his career in agriculture, Mr.  
15 Shearrer raised cattle with his family and worked for many years  
16 with the Wilco Peanut Company as a buyer in Jourdanton; he also  
17 established Simco Construction, which has been building homes and  
18 offices in South Texas for three decades; and

19           WHEREAS, A fifth-generation son of the Pleasanton area, Mr.  
20 Shearrer was a leader in his community for most of his life; he  
21 served as an Atascosa County commissioner for eight years, and he  
22 also served as president of the Pleasanton Chamber of Commerce and  
23 the Pleasanton Airport Board, as a director of the Pleasanton  
24 Cowboy Homecoming Association and Texas AgFinance, and as a member

1 of the Alamo Area Council of Governments and the Evergreen  
2 Underground Water Conservation District; and

3 WHEREAS, In recent years, Mr. Shearrer had become a leading  
4 advocate of weather modification research and technology, serving  
5 as president of the South Texas Weather Modification Association,  
6 the Texas Weather Modification Association, and the National  
7 Weather Modification Association; he had been interviewed about  
8 cloud seeding on the ABC News program *Nightline*, and he was featured  
9 in the critically acclaimed documentary *Owning the Weather*; and

10 WHEREAS, Mr. Shearrer was also a man of deep religious faith;  
11 he helped found Gateway Church in Pleasanton, serving as an elder  
12 and a Sunday school teacher; he was respected and admired by his  
13 fellow congregants as a man who lived according to his beliefs and  
14 ideals and who was able to express his faith in a frank and  
15 plainspoken way; and

16 WHEREAS, Though it is impossible to gauge the full effect of  
17 one man's life, some individuals leave their unmistakable mark on  
18 the world as they move through it, and Tommy Shearrer has left  
19 behind a legacy that will long resonate in the lives of all who knew  
20 him; now, therefore, be it

21 RESOLVED, That the House of Representatives of the 83rd Texas  
22 Legislature hereby pay tribute to the memory of Tommy Dean Shearrer  
23 and extend sincere condolences to the members of his family: to his  
24 wife, Sharon Shearrer; to his parents, Carl Dean "Tinker" and  
25 Beverly Shearrer; to his sons, Wesley Dean Shearrer and his wife,  
26 Magen, and Matthew Wright Shearrer and his wife, Amanda; to his  
27 brothers, Randy Shearrer and his wife, Sharon, and Justin Shearrer

1 and his wife, Natalie; to his in-laws, Dan and Dorothy Yow, Johnny  
2 and Mary Yow, Sheryl and Artie Armstrong, and Sandra and Larry  
3 Wheeler; to his nieces and nephews, Megan and James Martin, Mindy  
4 and Mark Giebel, Melany, Cody, Sadie, and Jason Shearrer, Jimmy and  
5 Kandace Bartosh, Jennifer and Chad Wheat, Roper and Amber Yow,
