1 WHEREAS, Family and friends are mourning the loss of Lynne
2 Ann Pennington of Arlington, who passed away on August 2, 2012, at
3 the age of 60; and

4 WHEREAS, Born in Ohio on October 27, 1951, to George and Nancy
5 Stearns, Ms. Pennington fulfilled her childhood dream of becoming a
6 teacher by earning a degree in education from Lock Haven University
7 in 1973; during that same year, she married her high school
8 sweetheart, Adlai Pennington, and in time their family grew to
9 include a beloved daughter and two cherished grandchildren; and

10 WHEREAS, After moving to Texas in 1983, Ms. Pennington
11 continued her teaching career at The Oakridge School in Arlington,
12 where she remained a member of the faculty until her retirement in
13 2002; a dedicated educator who practiced her vocation with passion,
14 she consistently encouraged her students to reach their highest
15 potential; and

16 WHEREAS, Ms. Pennington faced some very daunting challenges
17 after being diagnosed with ovarian cancer in 2004; although the
18 disease disrupted her travel and leisure activities, she inspired
19 others by battling her illness with bravery and grace; despite the
20 difficulties she encountered, she committed herself to helping
21 others, and her efforts included the establishment of the Pay It
22 Forward Foundation, to provide support services and to create a
23 safety net for individuals in need; and

24 WHEREAS, A devoted mother and grandmother, Ms. Pennington

1 enjoyed playing in the swimming pool with her grandchildren, made
2 award-winning quilts, and relished the company of friends and the
3 taste of sushi rolls and miso soup; her zest for life was infectious
4 and unquenchable; and

5 WHEREAS, Lynne Pennington's days were rich in family,
6 friends, and meaningful achievements, and she will forever be
7 remembered with tenderness and affection by all who were privileged
8 to know her; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 83rd Texas
10 Legislature hereby pay tribute to the memory of Lynne Ann
11 Pennington and extend sincere condolences to the members of her
12 family: to her loving husband of 38 years, Adlai Pennington; to her

14 grandchildren, Emma and Wyatt Gray; to her sister, Mary Jo Stearns;
