Bell High School, where she played a number of sports; after continuing her athletic career 13 14 as a volleyball and basketball player in college, she returned to North Texas and became an educator with the Hurst-Euless-Bedford 15 Independent School District in 1974; she worked first at Hurst 16 Junior High, and during her three years at the school, she created a 17 multisport curriculum for junior high girls that was used 18 throughout the district; she also coached several sports and 19 20 ultimately guided H-E-B students in volleyball, basketball, 21 cross-country, and track; and

WHEREAS, In 1977, she became the first girls' basketball head coach at L. D. Bell High School and held the post for 14 years; her exceptional work in guiding the Lady Raiders earned her the

- 1 Northeast Tarrant County Coach of the Year award in 1985, and her
- 2 teams claimed three district titles and qualified for the play-offs
- 3 each year between 1982 and 1989; she has continued to serve the
- 4 district in other capacities and currently works in the Technology

- 7 advance the proud tradition of athletic excellence in the
- 8 Hurst-Euless-Bedford school system, and she is indeed deserving of
