18 WHEREAS, Mr. Hawkins was an active member of the community as 19 well, serving on the Weslaco Ambulance Advisory Board, with the 20 Weslaco Lions Club, and with the Mid-Valley Medical Foundation; in 21 addition, he contributed to local charities; in his spare time, he 22 liked to golf, and he also studied Freemasonry; and

23 WHEREAS, In all of his endeavors, Mr. Hawkins enjoyed the 24 love and support of his wife, Irma, and he took pride in a fine
