1 WHEREAS, A full and generous life drew to a close with the 2 passing of Ruth Walker Polan of Nixon on January 13, 2013, at the 3 age of 84; and

WHEREAS, The daughter of Tom and Hertha Walker, the former 4 5 Ruthie Walker was born in Nixon on April 8, 1928; she grew up during the Great Depression and demonstrated her resourcefulness at an 6 7 early age, earning money by cleaning a local church; as a teenager, she found a job at the drugstore soda fountain, where a customer 8 9 named Glenn Polan developed the habit of stopping by on a daily basis for a scoop of ice cream and a chat; they later married and 10 11 became the proud parents of two sons, Glenn and Ted; and

12 WHEREAS, Mrs. Polan was employed as a clothes buyer for Joske's department store and as a civil servant in San Antonio 13 14 before embarking on a distinguished career in education; she held both a bachelor's and a master's degree and served a number of 15 school districts as a teacher and administrator; following Mr. 16 Polan's retirement, she joined him in founding an international 17 tour and travel company, which allowed her to fulfill her dream of 18 seeing the world; the couple visited more than 70 different 19 countries, and she started an import company, Ruthie's of Houston, 20 21 which turned into a successful wholesale jewelry business; and

WHEREAS, While pursuing a busy professional life, Mrs. Polan never failed to put her loved ones first; she found time to whip up fabulous dishes, and her recipes became staples at gatherings of

- 4 innumerable people, and during the time her husband served as the
- 5 director of the Methodist Student Center in Huntsville, Mrs. Polan
- 6 took in many young women who needed a place to stay, often giving
- 7 them clothing as well as food and shelter; when homeless men showed
- 8 up at the door, she gave them food, a smile, and sometimes a little
- 9 spare cash from the cookie jar; with a boundless will to serve, she
- 10 was always the first to deliver a meal to an ailing friend,
- 11 volunteer for a church garage sale, or organize opposition to a
- 12 highway that threatened quality of life in the neighborhood; and
- WHEREAS, Through the years, Mrs. Polan faced any challenges
- 14 she met with grace, and whatever transpired, she remained a source
- 15 of joy and inspiration; she also continued to share with her husband
- 16 their special daily ritual, an afternoon ice cream treat; and
- 17 WHEREAS, Ruthie Polan enriched countless lives through her
- 18 warm and caring ways, and she will forever hold a special place in
- 19 the hearts of those who were fortunate enough to know her; now,
- 20 therefore, be it
- 21 RESOLVED, That the House of Representatives of the 83rd Texas
- 22 Legislature hereby pay tribute to the memory of Ruth Walker Polan
- 23 and extend sincere sympathy to the members of her family: to her
