RESOLUTION

- 1 WHEREAS, Residents of College Station are celebrating the
- 2 75th anniversary of the founding of their city in 2013; and
- 3 WHEREAS, In 1877, the College Station post office opened near
- 4 the site of Texas A&M College, as the university was then known; the
- 5 surrounding community took its name from the postal station, and
- 6 within seven years, it had a population of 350 served by two general
- 7 stores and a railroad depot; and
- 8 WHEREAS, Local citizens voted to incorporate as College
- 9 Station on October 19, 1938; at the time, the town encompassed about
- 10 two square miles and had some 2,000 residents; the zoning
- 11 commission was created the following year and established a
- 12 tradition of managed growth; in 1942, Ernest Langford was elected
- 13 mayor, and during more than a quarter-century in office, the man
- 14 known as the "Father of College Station" emphasized the development
- 15 of city services over commercial expansion; and
- WHEREAS, By 1950, College Station had nearly 8,000
- 17 inhabitants, including students, and in the following decade, a
- 18 major expansion program at Texas A&M initiated a long period of
- 19 significant growth; between 1960 and 2000, the population increased
- 20 almost sixfold; ties to the university also drove the development
- 21 of the business sector, including manufacturing, and the city
- 22 became a major research center; and
- WHEREAS, College Station today covers about 50 square miles,
- 24 and the 2010 census recorded almost 94,000 residents; while much

- 1 has changed over the years, the city is committed to preserving and
- 2 sharing its unique history through such initiatives as the
- 3 Exploring History Lunch Series and the Historic Marker Program;
- 4 Project HOLD, College Station's Historic Online Library Database,
- 5 won the Award of Excellence in Preserving History from the Texas
- 6 Historical Commission in both 2005 and 2007, and it received the
- 7 Leadership in History Award from the American Association of State
- 8 and Local History; moreover, the city has partnered with the George
- 9 Bush Presidential Library and Museum to develop an exhibit
- 10 commemorating the 75th anniversary of incorporation; and
- 11 WHEREAS, The residents of College Station may take
- 12 justifiable pride in the rich heritage of their city as they look
- 13 forward to a future filled with promise and prosperity; now,
- 14 therefore, be it
- RESOLVED, That the House of Representatives of the 83rd Texas
- 16 Legislature hereby commemorate the 75th anniversary of the founding
- 17 of the city of College Station and encourage Texans to explore the
- 18 history of the community during this milestone year.
