R E S O L U T I O N

1 WHEREAS, The Brazosport Area Chamber of Commerce named  
2 Lucilla Henderson of Lake Jackson its 2011 Woman of the Year; and

4 attended Brazoswood High School and Brazosport College before  
5 earning a bachelor's degree in business administration from Texas  
6 State University--San Marcos in 1982; she subsequently worked as  
7 the general manager of Brazos Mall for 18 years, and she currently  
8 serves as vice president of marketing at the Texas Dow Employees  
9 Credit Union in Lake Jackson; and

10 WHEREAS, Deeply engaged in her community, Ms. Henderson has  
11 served on the Brazosport College Board of Regents since 2007, and  
12 she also serves on the executive committee that is coordinating  
13 Lake Jackson's 70th anniversary celebration in 2013; in addition,  
14 she has been involved with Junior Achievement of Brazoria County,  
15 the Economic Development Alliance for Brazoria County, SPCA of  
16 Brazoria County, the Brazoria County Association for Citizens with  
17 Handicaps Roll 'N Stroll event, the youth ministry at St. Michael's  
18 Catholic Church in Lake Jackson, and the Lake Jackson Development  
19 Corporation; moreover, she formerly chaired the Brazosport Area  
20 Chamber of Commerce Board of Directors, and she created the first  
21 Senior Fest in the Brazosport area; and

23 Brazosport College in 2004, in recognition of her myriad
