RESOLUTION

- 1 WHEREAS, The 90th birthday of an esteemed Texan is indeed a
- 2 special occasion, and the Honorable Carl Everett Lidell of Jonah
- 3 marked that significant milestone in his life on February 23, 2013;
- 4 and
- 5 WHEREAS, Born in Taylor in 1923, Mr. Lidell is the son of Per
- 6 and Myrtle Lidell; he worked on the family farm in Jonah as a boy,
- 7 and he was issued his driver's license at the age of 12, allowing
- 8 him to transport his three sisters to school and confirmation
- 9 classes in a Model T coupe; after graduating from Georgetown High
- 10 School, he attended Southwestern University, where he played guard
- 11 on the football team; he later transferred to The University of
- 12 Texas at Austin and was employed part-time on the staff of a state
- 13 senator; and
- 14 WHEREAS, Mr. Lidell enlisted in the United States Navy in
- 15 1943 and trained stateside as a pilot; when his unit was disbanded,
- 16 he was honorably discharged from the navy and promptly reenlisted
- 17 in the U.S. Merchant Marine, serving his country in the Pacific
- 18 theater during World War II; and
- 19 WHEREAS, Following demobilization, Mr. Lidell returned to
- 20 help his father on the farm; he married the former Marie Pearson in
- 21 1949, and they became the parents of three sons, John, Lynn, and
- 22 Michael; in the 1960s, the Lidells purchased the family farm and
- 23 additional acreage, and Mr. Lidell also began farming another 200
- 24 acres owned by his wife's family; he was named Williamson County

- 1 Agriculturalist of the Year and Outstanding Conservation Farmer in
- 2 1970; an individual of diverse talents, he earned his real estate
- 3 license in 1984 and was affiliated with Clyde Swenson Real Estate
- 4 and then TEX US Real Estate and Investments; and
- 5 WHEREAS, This admired civic leader joined with four other
- 6 citizens to found the Jonah Water Supply Corporation in 1970; over
- 7 subsequent decades, it grew to serve thousands of people and became
- 8 the Jonah Water Special Utility District; Mr. Lidell helped guide
- 9 its operations as president and general manager, and he continues
- 10 to serve as a member of the board; and
- 11 WHEREAS, Mr. Lidell's dedication to his community was further
- 12 demonstrated through his work as a county commissioner from 1977 to
- 13 1984; moreover, he has been active in Rotary International for many
- 14 years, and he has served the congregation at Hutto Lutheran Church
- 15 as a Sunday school teacher, as superintendent, and as a member and
- 16 president of the church council; and
- 17 WHEREAS, Following the death of Marie Lidell in 1996,
- 18 Mr. Lidell was fortunate enough to find love a second time, and he
- 19 married the former Alice L. "Grace" Bulgerin in 1998; the couple
- 20 have shared their time and talents with Angel Food Ministries, and
- 21 in 2009 they were named Volunteers of the Year by the Hutto Area
- 22 Chamber of Commerce; in addition, Mr. Lidell is the recipient of the
- 23 Distinguished Service Award from Jonah Community, Inc., and that
- 24 honor is indeed a fitting tribute to a man who is known to many as
- 25 "Mr. Jonah"; and
- 26 WHEREAS, Carl Everett Lidell has devoted himself to making
- 27 positive contributions in behalf of his fellow citizens, and his

- 1 kindness, warmth, and wonderful sense of humor have enriched the
