1 WHEREAS, Countless lives were touched by the kindness and
2 generosity of C. C. Smitherman, who passed away on October 12,
3 2012, at the age of 78; and

4 WHEREAS, Born in Franklin to Audie and Cleo Smitherman,
5 C. C. Smitherman became the first member of his family to graduate
6 from college when he earned a degree in agricultural education from
7 Texas A&M University in 1956; he went on to serve his community in a
8 number of ways, including as the representative for Harris County
9 on the Port of Houston Authority for eight years; he was appointed
10 by Texas Governor Mark White as a commissioner with the Texas
11 Turnpike Authority, and he was also a member of the North Shore
12 Rotary Club, the North Shore Chamber of Commerce, and the Highlands
13 and New Braunfels United Methodist Churches; and

14 WHEREAS, Mr. Smitherman was particularly devoted to the
15 Houston Livestock Show and Rodeo; he attended it without fail for
16 four decades, and for 37 of those years he served on various
17 organizational committees and in leadership roles; he sponsored or
18 served as a champion buyer of livestock, and he distinguished
19 himself as a director and vice president of the event; he was named
20 a lifetime vice president in 1993; and

21 WHEREAS, His family's ranch in Medina County, where he raised
22 Beefmaster cattle, held a special place in Mr. Smitherman's heart;
23 he was also a skilled marksman and enjoyed hunting; and

24 WHEREAS, In all of his endeavors, Mr. Smitherman enjoyed the

1 love and support of his wife of 56 years, Billie Smitherman; he took
2 great pride in their two children, Barry and Leslie, and their six
3 grandchildren; and

4 WHEREAS, C. C. Smitherman lived a rich and purposeful life,
5 and he will long be remembered with admiration and affection by all
6 who had the good fortune to know him; now, therefore, be it

7 RESOLVED, That the House of Representatives of the 83rd Texas
8 Legislature hereby pay tribute to the memory of C. C. Smitherman
9 and extend sincere condolences to the members of his family: to his
10 wife, Billie Smitherman; to his children, Barry Smitherman and his
11 wife, Marijane, and Leslie Rutherford and her husband, Jeff; to his
12 grandchildren, Shelton, Wyatt, Owen, Louisa, Jake and his wife,
13 Natalie, and Colton; to his sisters, Marie, Sue, and Doris; and to
14 his other relatives and friends; and, be it further
