1 WHEREAS, Brazoria County Veterans Service Officer John 2 Elwood Jerabeck of Angleton passed away on December 12, 2011, at the 3 age of 64, bringing a great loss to his family, friends, and fellow 4 citizens; and

5 WHEREAS, The son of Lieutenant Colonel J. Roland Jerabeck and 6 Alice Beckman Jerabeck, John Jerabeck was born in Houston on July 7 23, 1947; he graduated from Memorial High School and enlisted in the 8 United States Army in 1969; during the Vietnam War, he served as a 9 tank commander in the Americal 23rd Infantry Division; and

10 WHEREAS, This proud combat veteran went on to earn his 11 bachelor's degree in economics and business administration from the 12 University of St. Thomas; for many years, he worked in the energy 13 industry for a number of oil field-related companies, among them 14 Cameron Iron Works; and

WHEREAS, Committed to improving the lives of others who had 15 16 served their country, Mr. Jerabeck became Veterans Service Officer for Brazoria County in 1997; he collaborated closely with the 17 Michael E. DeBakey Veterans Affairs Medical Center as a member of 18 its Veterans Satisfaction Committee and Management Advisory 19 Council to ensure that area Texans who had served their country 20 21 received the best possible care, and he was instrumental in bringing the VA Medical Clinic to Brazoria County; moreover, he 22 23 played a key role in the establishment of an annual, countywide Veterans Day parade and celebration; and 24

1 WHEREAS, Mr. Jerabeck further distinguished himself as director of the Veterans County Service Officer 2 regional 3 Association, and he was deeply involved in the development of the Ring of Honor memorial, chairing the committee in charge of the 4 5 effort from its first meeting in early 2007; in addition, he was active in the American Legion, Veterans of Foreign Wars, Disabled 6 American Veterans, Vietnam Veterans Association, and Americal 23rd 7 8 Division Association, and he benefited the wider community as a member of the Knights of Columbus; and 9

10 WHEREAS, Mr. Jerabeck was named the 2000 Outstanding Veterans Service Officer of the Year by the Veterans Service 11 12 Officer Association of Texas; he was also the recipient of numerous other awards, including the Citation for Meritorious Service from 13 14 the American Legion National Veterans Affairs Rehabilitation Commission, the County Service Officer Annual Appreciation Award 15 from the Texas Veterans Commission, and the Legion of Honor Award 16 17 from the Chapel of Four Chaplains; and

18 WHEREAS, A devoted family man, Mr. Jerabeck shared 28 years 19 of marriage with his wife, Suzanne, and he was the proud father of 20 two children, Jessica and Joseph; in his leisure time, he enjoyed 21 riding his Harley-Davidson motorcycle and relaxing at the beach in 22 his recreational vehicle; he found inspiration in the poem 23 "Desiderata" and had it printed on business cards to give to people 24 he met; and

WHEREAS, John Jerabeck dedicated his life to meaningful service in behalf of his fellow veterans, and those who were privileged to know him will long remember the way he touched their
