1 WHEREAS, A full and generous life drew to a close with the
2 passing of Suzanne Schoenemann Johnson of Houston on June 15, 2011,
3 at the age of 73; and

4 WHEREAS, Suzanne Schoenemann was born in Wharton on October
5 15, 1937, to Burford and Ruth Struve Schoenemann; raised in
6 Brenham, she was a graduate of Brenham High School and Sam Houston
7 State University; and

8 WHEREAS, Miss Schoenemann was joined in matrimony to Edward
9 Durrion Johnson in 1959, and they shared a loving relationship for
10 more than half a century; they were blessed with three children,
11 Edward, James, and Diane, and seven grandchildren; and

12 WHEREAS, A resident of Houston for over 50 years,
13 Mrs. Johnson was a former teacher and a longtime friend of the
14 Spring Branch Independent School District; while her children were
15 growing up, she volunteered as a Girl Scout and Cub Scout leader and
16 played an active role in the PTA, serving as president of that
17 organization at Bunker Hill Elementary School, Spring Branch Middle
18 School, and Memorial High School; and

19 WHEREAS, Among the other organizations to which she gave
20 generously of her time and talents were the Assistance League of
21 Houston and the Zeta Tau Alpha Alumni Association; she was also a
22 lifelong supporter of the Brenham Maifest and a valued member of
23 Chapelwood United Methodist Church, which she joined in 1962; and

24 WHEREAS, Beloved for her warmth, good cheer, and kind spirit,

1 Suzanne Johnson enriched immeasurably the lives of her family and
2 many friends, and they will forever hold her close in their hearts;
3 now, therefore, be it
