RESOLUTION

1 WHEREAS, The State of Texas lost a revered elder statesman 2 with the death of the Honorable Raymond L. Telles, Jr., on March 8, 3 2013, at the age of 97, and his passing has deeply saddened admirers 4 across the Lone Star State and beyond; and

5 WHEREAS, A trailblazer in government and international 6 diplomacy, Raymond Telles was the first Hispanic mayor of a major 7 American city and the first Hispanic United States ambassador; he 8 led El Paso from 1957 to 1961, and his effective management paved 9 the way for other Latinos in politics across the nation; and

WHEREAS, Ambassador Telles was born in El Paso to Ramon and 10 Angela Telles on September 5, 1915; after graduating from Texas 11 12 Western College, he began his career with the United States Department of Justice; he answered his nation's call to duty in 1941 13 14 with service in the United States Air Force and eventually attained the rank of colonel; along the way, he served as chief of the 15 lend-lease program for South and Central America and as a military 16 aide to Presidents Harry S. Truman and Dwight D. Eisenhower, and 17 for his accomplishments, he received the Order of the Southern 18 Cross from Brazil, Columbian wings, the Mexican Legion of Merit, 19 20 and the Peruvian Flying Cross; and

21 WHEREAS, Following World War II, Colonel Telles returned to 22 his hometown, where he was elected to the first of four terms as El 23 Paso County Clerk; he was recalled to military service during the 24 Korean War and commanded the U.S. Air Force 67th Tactical and

Reconnaissance Group, for which he earned the Bronze Star Medal;

3 WHEREAS, This remarkable Texan overcame prejudice and persevered to win a hard-fought 1957 mayoral campaign, and his 4 5 skill, expertise, and collaborative management style won him an uncontested second term; in 1961, he left the office of mayor when 6 he was appointed ambassador to Costa Rica by President John F. 7 8 Kennedy; he was subsequently named chair of the U.S.-Mexico border commission by President Lyndon B. Johnson, and he went on to serve 9 10 as head of the Equal Employment Opportunity Commission during both the Nixon and Ford administrations; throughout his tenure in the 11 federal government, he was a valued advisor and friend to both 12 Republican and Democratic presidents; and 13

14 WHEREAS, While at home in the halls of power, Ambassador 15 Telles was naturally modest, and he unfailingly credited those who helped him accomplish his goals; he was, in turn, a wise and caring 16 17 mentor who personally helped to nurture succeeding generations of Latino leaders; he was named Mayor Emeritus of El Paso in 2006, and 18 19 he was recognized for a lifetime of achievement by the Hispanos Triunfadores Awards program in 2008, among myriad other accolades; 20 21 and

22 WHEREAS, Mr. Telles shared a fulfilling marriage of 68 years 23 with the love of his life, Delfina Navarro, and he was devoted to 24 his daughters, Cynthia and Patricia, and his two grandsons, Raymond 25 and Daniel; and

26 WHEREAS, Through his commitment to progress and his selfless 27 dedication to public service, Raymond Telles made a lasting,

1 positive difference in the world around him, and his achievements 2 will continue to inspire his fellow Texans and all Americans for 3 many years to come; now, therefore, be it
