- 11 Catholic Church, serving as a youth minister and parish council
- 12 president; he is also an honorary member of the local Rotary Club
- 13 and has volunteered his time with the Boys & Girls Club of McAllen
- 14 Metro for many years; and
- WHEREAS, In recognition of his work, Mayor Cortez has
- 16 received numerous accolades, including the first Teddy Roosevelt
- 17 Leadership Award given by the McAllen Chamber of Commerce and the
