- 12 Star, Distinguished Flying Cross, Air Medal with two oak leaf
- 13 clusters, and European-African-Middle Eastern Campaign Ribbon with
- 14 three bronze stars; and
- WHEREAS, Mr. Scheumack subsequently earned a bachelor's
- 16 degree in electrical engineering from Texas A&M University; he was
- 17 employed by the Dashiell Corporation for a quarter of a century and
- 18 was a member of the Professional Engineers and the Electrical and
- 19 Electronic Engineers; and
- WHEREAS, For 43 years, until he turned 70, Mr. Scheumack
- 21 refereed high school football games; during his tenure, he presided
- 22 over two regional football officials' associations and received two
- 23 distinguished service awards and an honorary life membership from
- 24 officials' and coaches' associations; in his leisure time, he was an

- 1 enthusiastic vegetable gardener and bridge player and was active in
