

R E S O L U T I O N

1           WHEREAS, Family and friends are mourning the loss of  
2 Nathaniel Bradshaw of Dallas, who passed away on March 24, 2013, at  
3 the age of 82; and

4           WHEREAS, Born on January 21, 1931, in Houston, Nathaniel  
5 Bradshaw was the son of Celestine Bradshaw and James Bradshaw, Sr.;  
6 he grew up with nine siblings in Colfax, Louisiana, and enlisted in  
7 the United States Army in 1951, serving for three years before being  
8 discharged; and

9           WHEREAS, Mr. Bradshaw moved to Dallas in 1954 and was hired as  
10 a truck driver the following year, becoming the first African  
11 American driver to work for what would become Sanger-Harris; he was  
12 employed by the company for more than three decades; retiring in  
13 1988, he went on to drive school buses for another 17 years; and

14           WHEREAS, A man of faith, Mr. Bradshaw became an elder at the  
15 East Dallas Church of Christ in 1968, and he further served the  
16 church as treasurer, as a Sunday school teacher, and as the driver  
17 of the church bus; in his spare time, he enjoyed fishing; and

18           WHEREAS, This esteemed Texan shared nearly six decades with  
19 his beloved wife, the former Dorothy Mae Turner, whom he married in  
20 1954; the couple were blessed with three daughters, Sharon, Denise,  
21 and Marsha, and Mr. Bradshaw also took great pride in his grandsons,  
22 Jason, Nathan, Aulston, and Kevin; and

23           WHEREAS, Nathaniel Bradshaw was a devoted husband, father,  
24 and grandfather, and he leaves his family and friends with a wealth

1 of cherished memories of the many happy times spent in his company;  
2 now, therefore, be it

3       RESOLVED, That the House of Representatives of the 83rd Texas  
4 Legislature hereby pay tribute to the life of Nathaniel Bradshaw  
5 and extend sincere sympathy to the members of his family: to his  
6 wife, Dorothy Bradshaw; to his children, Sharon Faye Washington,  
7 Denise Hervey and her husband, Charles Hervey, Jr., and Marsha Ann  
8 Bradshaw; to his grandsons, Jason Hervey, Nathan Hervey and his  
9 wife, Crystal, Aulston Bradshaw, and Kevin Hervey; to his sisters,  
10 Barbara Culbreth and Deloris Ann Hines and her husband, Al; to his  
11 brother, Herbert Bradshaw, and his wife, Betty; and to his other
