RESOLUTION

1 WHEREAS, The life of a respected public servant, 2 entrepreneur, and family man drew to a close with the passing of E. C. Locklear on March 2, 2013, at the age of 87; and 3 WHEREAS, A native of El Dorado, Arkansas, E. C. Locklear was 4 5 born to Dewey and Sarah Locklear on April 4, 1925; he grew up in Arp, Texas, and met his future wife, Hazel Nina Hune, when both were 6 7 still children; they were married in 1943, shortly before he 8 entered the United States Army; he served in the 9 European-African-Middle Eastern theater during World War II and then took part in the occupation of Japan as part of the 24th 10 11 Infantry Division; while stationed in Japan, he played tackle for 12 his division's football team and was named an all-star for his outstanding performance; after returning to the United States, he 13 14 was recalled to active duty during the Korean War and ably served his nation in that conflict; and 15 WHEREAS, Mr. Locklear went on to pursue a career in law 16 enforcement and graduated from Texas Highway Patrol Training School 17 in 1954; assigned to a duty station in Kermit, he patrolled about 18 500 miles of state and county roads in Winkler and Loving Counties, 19 20 often as the only highway patrol officer in the area; he earned his 21 scuba diving certification in order to assist with search and rescue missions and later patrolled the roads around Fort Stockton; 22 23 a prominent figure in the region, he was known for his trademark

sunglasses and cigar, and he earned a reputation as a tough but fair

- 2 WHEREAS, After retiring from the Texas Department of Public
- 3 Safety, Mr. Locklear was twice elected as county judge in Winkler
- 4 County, serving for a total of eight years; he moved to Del Rio in
- 5 1979 and operated Fisherman's Headquarters, and he made many
- 6 friends among anglers and local fishing guides; in the later years
- 7 of his life, he divided his time between Del Rio and his property in
- 8 the Davis Mountains, an area he dearly loved for its beauty and
- 9 tranquility as well as for the fellowship he enjoyed at Davis
- 10 Mountain Community Church; and
- 11 WHEREAS, In all of his endeavors, Mr. Locklear was supported
- 12 by a loving family, which included his wife, Hazel, and his
- 13 daughters, Nina and Susan; and
- 14 WHEREAS, E. C. Locklear possessed a strength of character
- 15 and a generosity of spirit that won him the admiration of many
- 16 people, and he is deeply missed by all those whose lives were
- 17 enriched by his love and friendship; now, therefore, be it
