4 investment firm, and was co-owner of Meinhard Galleries with
5 Mrs. Legate; and

6 WHEREAS, Mr. and Mrs. Legate have traveled widely in the
7 United States and Europe for business and pleasure, have been
8 members of the Houston Racquet Club, and have been active members of
9 Bethel Independent Presbyterian Church of Houston for more than
10 four decades; Mrs. Legate taught Sunday school at the church for 30
11 years, and Mr. Legate reorganized and operated the church library
12 of 6,000 volumes and sang in the choir, performing great classical
13 anthems of the church; and
