- WHEREAS, Born and raised in the Sun City, Major General
- 5 Pittard graduated in 1977 from Eastwood High School, where he was
- 6 elected president of his class all four years; he went on to attend
- 7 the United States Military Academy at West Point and to earn a
- 8 master's degree from the School for Advanced Military Studies at
- 9 the United States Army Command and General Staff College; after
- 10 dedicated service stateside and overseas, he returned to El Paso in
- 11 2010 to serve as post commander of Fort Bliss; and
- 12 WHEREAS, Since taking up his present assignment, Major
- 13 General Pittard has been committed to making Fort Bliss a premier
- 14 national training center; to that end, he has introduced a new
- 15 training model and nearly doubled the size of the training arena; he
- 16 has also made mental and emotional health services and family and
- 17 soldier support systems a top priority; and
- WHEREAS, During his tenure at Fort Bliss, this distinguished
- 19 officer has overseen one of the largest expansions of any U.S.
- 20 military base since World War II; in addition to increasing the
- 21 training area, he has overseen the groundbreaking for a new

- 23 district for soldiers and the public; he has also worked to promote
- 24 energy efficiency and resource conservation, with the goal of
