RESOLUTION

1 WHEREAS, Autism is the general term for a group of complex 2 neurodevelopmental disorders that are estimated to impact 1 to 1.5 million American adults and as many as 1 out of every 50 children; 3 those living with autism in Texas number approximately 260,000; and 4 5 WHEREAS, Symptoms of autism typically emerge during the first three years of life and include varying degrees of difficulty in 6 social interaction and communication and the presence of certain 7 repetitive behaviors; persons affected by autism may also 8 9 experience intellectual disabilities, motor coordination impairment, and physical health issues, 10 such as sleep and 11 gastrointestinal disturbances; and WHEREAS, While there is no known cure for autism, early diagnosis and intervention can drastically alleviate symptoms and

WHEREAS, While there is no known cure for autism, early diagnosis and intervention can drastically alleviate symptoms and can reduce the cost of lifelong care by as much as two-thirds; research has further underlined the significance of family involvement, making connecting families with autism education and resources a priority of particular urgency; and

WHEREAS, The United States is home to a number of advocacy groups dedicated to ensuring that all persons living with autism receive appropriate and effective treatment and to allaying the challenges and expenses faced by their loved ones; and

WHEREAS, One such group is the Autism Society of America, one of the oldest and largest grassroots organizations of its kind in the nation; composed of 107 local and statewide affiliates, the

- 2 information, referrals, and support services to help affected
- 3 individuals reach their full potential and attain an optimal
- 4 quality of life; and
- 5 WHEREAS, This admirable group offers a wealth of important
- 6 resources, including a national contact center that each month
- 7 responds to over 24,000 people in need of answers or assistance; the
- 8 society also hosts one of the longest-running and most
- 9 comprehensive national conferences on autism, a gathering that
- 10 brings together the expertise and experience of professionals,
- 11 family members, and individuals along the autism spectrum to build
- 12 more effective advocacy and support strategies; and
- WHEREAS, Another organization worthy of note is Autism
- 14 Speaks, founded in 2005 by Bob and Suzanne Wright, grandparents of a
- 15 child with autism, and their longtime friend Bernie Marcus, whose
- 16 \$25 million donation was instrumental to the group's launch; Autism
- 17 Speaks has since grown into a leading worldwide research sponsor,
- 18 having committed over \$160 million toward investigations into the
- 19 causes, prevention, and treatment of autism; and
- WHEREAS, In addition to its range of research endeavors, the
- 21 organization's focus includes the Autism Speaks Autism Treatment
- 22 Network, the Autism Speaks Autism Genetic Resource Exchange, and
- 23 various other scientific and clinical programs, as well as
- 24 awareness initiatives like the Light it Up Blue project; moreover,
- 25 members of its Government Relations Team have successfully
- 26 campaigned in behalf of federal legislation concerning persons with
- 27 autism, in particular insurance reform to cover behavioral

- 1 treatments; and
- WHEREAS, On April 30, 2013, representatives of the Autism
- 3 Society of America and Autism Speaks are joining with other
- 4 concerned individuals from across the state in Austin to observe
- 5 Texas Autism Awareness Day; designed to increase public
- 6 understanding of the rights and abilities of autistic persons and
- 7 to draw attention to advocacy efforts, this event is among many ways
- 8 that Texans and their national allies are working to foster an
- 9 environment of compassion, encouragement, and acceptance for all
- 10 those touched by autism; now, therefore, be it
