RESOLUTION

- 1 WHEREAS, Cyclists are gearing up for the Hotter'N Hell
- 2 Hundred bike ride in Wichita Falls in August 2013, an annual event
- 3 that has attracted about 300,000 participants over the course of
- 4 the last three decades; and
- 5 WHEREAS, The Hotter'N Hell Hundred was first staged during
- 6 the town's centennial in 1982, with riders commemorating the 100th
- 7 anniversary by riding 100 miles in 100-degree weather; organized by
- 8 the Wichita Falls Bicycling Club and the centennial planning
- 9 committee, the inaugural countywide race drew 1,200 cyclists and
- 10 was, at the time, the largest single-day century ride in the nation;
- 11 and
- WHEREAS, With each successive year, the HHH attracted greater
- 13 attention in Wichita Falls, throughout surrounding counties, and
- 14 beyond; volunteers, businesses, nonprofit groups, and service
- 15 organizations began helping coordinate the ride, and attendance
- 16 remained strong; by 1987, 11,000 people had taken part in the
- 17 challenge, and as time went by, it became a favorite destination for
- 18 fitness enthusiasts from across the United States and around the
- 19 world; and
- WHEREAS, Now one of the nation's oldest and largest cycling
- 21 events, the HHH has expanded from a single-day to a four-day
- 22 gathering; among the features that have been added are
- 23 mountain-biking activities, trail runs, road and criterium races
- 24 sanctioned by USA Cycling, and a large trade show with food vendors

- 1 from around the country; and
- 2 WHEREAS, The number of volunteers has grown from 250 in the
- 3 first year to well over 5,000 in 2012, including 1,000 medical
- 4 personnel; embodying the strong community spirit in the local area,
- 5 the volunteers work to register riders, provide them with supplies,
- 6 attend to them at rest stops, and see them safely across the finish
- 7 line; any participants who are unable to complete the routes on
- 8 their own are driven to their destinations via volunteer-run sag
- 9 wagons; and
- 10 WHEREAS, Proceeds from the HHH are used to support a range of
- 11 worthwhile endeavors, including the development of parks, exercise
- 12 trails, and other public facilities; these contributions have, over
- 13 time, helped to rebuild the city's namesake waterfalls and to
- 14 construct the River Bend Nature Center and various historical
- 15 sculptures; the race has also underwritten scholarships for the
- 16 Midwestern State University Cycling Team and has benefited the Navy
- 17 Seabees and the U.S. Air Force at Sheppard Air Force Base, the
- 18 American Red Cross, the Children's Miracle Network, BikeTexas,
- 19 Wichita Falls Amateur Radio, and area police and fire departments;
- 20 and
- 21 WHEREAS, With its warm hospitality soothing the strain of its
- 22 rather inhospitable weather, the Hotter'N Hell Hundred has become
- 23 one of the classic cycling events in the United States and a
- 24 signature celebration for Wichita Falls, and it is indeed deserving
- 25 of special recognition; now, therefore, be it
- 26 RESOLVED, That the House of Representatives of the 83rd Texas
- 27 Legislature hereby commemorate the 32nd annual Hotter'N Hell

- 1 Hundred bicycle ride, honor the cyclists who have gamely set off at
- 2 the starting line over the past 31 years, and extend to all of the
- 3 race's riders, organizers, and volunteers sincere best wishes for a
