1 WHEREAS, Thomas Neumann of Houston, executive director 2 emeritus of the Jewish Institute for National Security Affairs, is 3 an exceptional leader whose achievements merit special 4 recognition; and

5 WHEREAS, JINSA is a think tank devoted to defense policy and 6 national security, and during his tenure with the group, 7 Mr. Neumann has helped it to become one of the fastest growing 8 Jewish organizations in the country with more than 20,000 members; 9 and

WHEREAS, In 1999, Mr. Neumann was voted the "Sixth Most Influential Jewish Leader" by *The Forward*, a Jewish American national newspaper; a notable speaker, he has made numerous television and radio appearances and addressed audiences on Capitol Hill and throughout the nation; and

23 WHEREAS, Before joining JINSA, Mr. Neumann served as the 24 executive vice president of B'nai B'rith International, and he held

1 leadership positions with the Anti-Defamation League, including 2 national director of the Intergroup Relations Division, national 3 director of Community Services, and Southwest regional director of 4 ADL activity in southern Texas; he also founded The Houston Center 5 for International Affairs, the Christian/Jewish Committee for 6 Israel, and Texas 1990; and

7 WHEREAS, Mr. Neumann returned to his hometown of Houston in 8 2011, and he continues to work on behalf of JINSA as executive 9 director emeritus and director of coalition development; he also 10 writes book reviews for the *Houston Chronicle* and op-ed columns and 11 articles for national newspapers; and

12 WHEREAS, Thomas Neumann has contributed his many talents to 13 the mission of the Jewish Institute for National Security Affairs, 14 and in so doing, he has become one of the foremost Jewish leaders in 15 the Lone Star State and the nation; now, therefore, be it

16 RESOLVED, That the House of Representatives of the 83rd Texas 17 Legislature hereby commend Thomas Neumann for his service to the 18 Jewish Institute for National Security Affairs and extend to him 19 sincere best wishes for continued success; and, be it further
