12 WHEREAS, Mr. Saenz began his longtime involvement with the 13 Texas and Southwestern Cattle Raisers Association in 1973; as a 14 member of that organization's special rangers, he was commissioned through the Texas Department of Public Safety and certified by 15 16 Texas A&M University--Kingsville; this esteemed law enforcement officer investigated such crimes as cattle rustling, equipment 17 theft, poaching, and agricultural fraud in six South Texas 18 counties--Duval, Jim Hogg, Webb, Zapata, Starr, and Hidalgo; his 19 20 territory included the border between Laredo and Brownsville, where 21 more than 20 crossing points offer opportunity for the transit of stolen cattle both to and from Mexico; in carrying out his duties, 22 23 Mr. Saenz worked closely with a number of agencies on both sides of

the Rio Grande; he also taught classes on livestock law and

- 2 certified marksmanship instructor helping to train police and law
