## RESOLUTION

- 1 WHEREAS, The State of Texas lost a distinguished native son
- 2 on April 19, 2013, with the passing of John F. Sutton, Jr., former
- 3 dean of The University of Texas School of Law; and
- WHEREAS, Born in Alpine on January 26, 1918, John Sutton was
- 5 the son of John and Pauline Sutton; he grew up in San Angelo and
- 6 worked on his father's ranch in Tom Green County before graduating
- 7 from San Angelo High School; while attending the UT School of Law,
- 8 he met a classmate, Nancy Ewing, whom he married on June 1, 1940;
- 9 the couple would go on to become the parents of two treasured
- 10 children, Nancy and John, and to share 72 years together; and
- 11 WHEREAS, Mr. Sutton graduated from law school with honors in
- 12 1941 and briefly practiced in San Antonio; at the start of World War
- 13 II, he joined the Federal Bureau of Investigation as a special
- 14 agent, and later, during the Korean War, he served as a first
- 15 lieutenant, Judge Advocate General's Corps, in the United States
- 16 Army Reserves; and
- WHEREAS, In 1950, Mr. Sutton returned to San Angelo to
- 18 practice law with his wife and his father, a retired district court
- 19 judge; his sterling qualifications led the UT School of Law to
- 20 appoint him as a tenured full professor in 1957 although he had
- 21 never taught law before, and he won a teaching excellence award very
- 22 early in his career; bringing real-world experience to the
- 23 classroom, he helped his students gain a greater understanding of
- 24 legal principles, and his sense of humor, as well as his intellect

- 1 and insight, made lessons especially memorable; he also taught at a
- 2 number of other institutions over the years, among them Texas Tech
- 3 University, the University of California, Los Angeles, and South
- 4 Texas School of Law; and
- 5 WHEREAS, This brilliant scholar gained national recognition
- 6 for his particular expertise in legal ethics, evidence, and torts;
- 7 he was one of the original drafters of the American Bar
- 8 Association's Model Rules of Professional Responsibility, and he
- 9 served two terms on its Standing Committee on Ethics and
- 10 Professional Responsibility; moreover, he served as chair of the
- 11 Professional Ethics Committee of the State Bar of Texas, and in
- 12 1977, he was the evidence advisor for the joint committee of the
- 13 Texas Senate and House of Representatives during its hearing
- 14 regarding Texas Supreme Court justice Don Yarbrough; Mr. Sutton was
- 15 the coauthor of two editions of Cases and Materials on Professional
- 16 Responsibility and of several editions of McCormick, Elliott, and
- 17 Sutton, Cases and Materials on Evidence; and
- 18 WHEREAS, Appointed head of the law school in 1979, Dean
- 19 Sutton promoted a collegial, productive environment, setting a
- 20 standard of excellence while retaining his easygoing, unassuming
- 21 ways; he dedicated himself to advancing the school's reputation
- 22 through the recruitment and retention of top-notch faculty, and he
- 23 was an inspiring mentor and role model; after concluding his tenure
- 24 as dean in 1984, he continued to teach until his retirement in 2003
- 25 at the age of 85, and at 90, he was appointed to the state bar's
- 26 Standing Committee on Disciplinary Rules of Professional Conduct;
- 27 and

- 1 WHEREAS, The law school presented Dean Sutton with its Outstanding Alumnus Award in 1990, and it later named one of its 2 3 eight societies in his honor and established the Dean John F. Sutton, Jr. Chair in Lawyering and the Legal Process through an 4 5 endowment by a former student; in addition, the Texas Law Review Association created the John F. Sutton, Jr. Endowed Presidential 6 Scholarship in Law, and the Texas Bar Foundation presented him with 7 8 an Outstanding 50 Year Lawyer Award; Dean Sutton was a fellow of the American Bar Foundation and a life member of the Texas Bar 9
- WHEREAS, In his leisure time, he loved to travel with his wife, and they visited every state in the country as well as many countries in Europe, Africa, and South America; he also raised Black Angus cattle and maintained horses at a small farm south of Austin; and

- 16 WHEREAS, John Sutton left a lasting imprint on the legal 17 profession and made a positive difference in innumerable lives; 18 although he will be deeply missed, his contributions will continue 19 to resonate for years to come; now, therefore, be it
