1 WHEREAS, A full and generous life drew to a close with the
2 passing of Jack Hinton Havis, a longtime resident of Baytown, on
3 April 27, 2013, at the age of 88; and

4 WHEREAS, Born to Hinton and Bonnie Havis in the Pelly
5 community on January 3, 1925, Jack Havis graduated from Cedar Bayou
6 High School in Baytown before being drafted into the United States
7 Army Air Forces in 1943; he attended aircraft mechanic school in
8 Reno, Nevada, and was deployed with the 9th Air Force to England,
9 where he served with the 365th Fighter Group and the 36th Mobile
10 Reclamation and Repair Unit, recovering and restoring downed
11 aircraft; he landed in Normandy shortly after the Allied invasion
12 and served in France and Germany through the end of the war; and

13 WHEREAS, After returning to the States, Mr. Havis attended
14 Lee College and began a long and productive career with Lubrizol
15 Corporation; he worked in the company's Deer Park and Bayport
16 plants and retired in 1986 after 32 years of dedicated service; and

17 WHEREAS, Mr. Havis found a life partner in his wife, Janice
18 Havis, with whom he shared more than six decades; the couple were
19 blessed with two sons, Dwayne and Neal; and

20 WHEREAS, In his leisure time, Mr. Havis enjoyed his
21 membership in the Bayshore Fine Rides Car Club and the Lubrizol
22 Legends; he was an avid fisherman and hunter, and he took special
23 pleasure in tending to the fruit trees, hibiscus plants, and cream
24 peas in his backyard garden; and

1 WHEREAS, Jack Havis treasured the time he spent in the
2 company of his family and friends, and those he leaves behind will
3 forever cherish their memories of this kind and caring man; now,
4 therefore, be it

5 RESOLVED, That the House of Representatives of the 83rd Texas
6 Legislature hereby pay tribute to the memory of Jack Hinton Havis
7 and extend sincere sympathy to the members of his family: to his
8 wife, Janice Havis; to his sons, Dwayne Havis and his wife, Celeste,
9 and Neal Havis; to his sister-in-law, Nan Bishop Owens; to his
10 sister, Mary Clanton, and her husband, Dalton; to his niece, Alecia
11 Boxley, and her husband, Edwin; and to his other relatives and
