4           WHEREAS, Linda Hill was born on October 15, 1943, in  
5 Livingston, the only child of Elmer and Maurine Dominy Hill; she  
6 graduated from Kirby High School in Woodville and attended Baylor  
7 University; her love of history led her to a career in education,  
8 teaching history to middle school students in the Eagle Lake and  
9 Lamar Consolidated Independent School Districts; she was an engaged  
10 and lively teacher, dressing up in period costumes and chaperoning  
11 summer tours of Washington, D.C., for her students; after retiring,  
12 she worked as a substitute teacher at Living Water Christian School  
13 and Fort Bend Baptist Academy; she also enjoyed writing and had  
14 recently penned a poem for her high school class's 50th reunion; and

15           WHEREAS, A woman of faith, Ms. Hill served as the Southwest  
16 District president for United Methodist Women and as a lay minister  
17 and reader for her church; in addition, she held many offices as a  
18 member of the Eastern Star, including worthy matron, and she was  
19 active in her community, playing the piano for local groups and  
20 organizations and performing in community theater productions; and

21           WHEREAS, While the death of Linda Hill brings immeasurable  
22 sorrow to her loved ones, she leaves behind a legacy of compassion  
23 and service that will long be treasured by all those who held her  
24 dear; now, therefore, be it
