- 1 WHEREAS, The life of a legendary sports broadcaster drew to a
- 2 close with the passing of Pat Summerall on April 16, 2013, at the
- 3 age of 82; and
- WHEREAS, George Allen Summerall was born in Florida on May
- 5 10, 1930; nicknamed "Pat" by his aunt and uncle, Mr. Summerall was a
- 6 gifted multisport athlete in high school; he went on to play
- 7 football, basketball, and baseball at the University of Arkansas,
- 8 where he earned a bachelor's degree in education and, later, a
- 9 master's degree in Russian history; and
- 10 WHEREAS, Selected by the Detroit Lions in the 1952 National
- 11 Football League draft, Mr. Summerall spent one year with that team
- 12 and five seasons with the Chicago Cardinals before joining the New
- 13 York Giants in 1958; though he sometimes played as a tight end or
- 14 defensive end, he became best known as a placekicker, and during his
- 15 first year with New York, he kicked a game-winning field goal in a
- 16 snowstorm to lead the team to the playoffs; he competed in three NFL
- 17 championship games with the Giants, and he retired after the 1961
- 18 season, having scored 563 points during his 10 years in the league;
- 19 and
- WHEREAS, Mr. Summerall got his start as an announcer at CBS
- 21 Radio, where he was hired to voice short feature stories while still
- 22 with the Giants; after concluding his playing career, he began
- 23 broadcasting NFL games, and during his more than 40 years in the
- 24 booth, he became one of the most popular announcers in professional

sports; known as "the voice of football," Mr. Summerall covered 37 1 NFL seasons, including 16 Super Bowls, and he was part of two famous 2 3 partnerships, working with Tom Brookshier in the 1970s and with John Madden from 1981 to 2001; his understated style 4 5 authoritative tone perfectly balanced Mr. Madden's lively and detailed delivery, and the duo produced numerous memorable 6 broadcasts, including Super Bowl XVI, the most-watched game in NFL 7 history; Mr. Summerall also served as an announcer for other 8 sports, calling 26 Masters Championships in golf and 21 U.S. Open 9 10 tennis tournaments; and

11 WHEREAS, He retired from broadcasting in 2002, having earned 12 numerous accolades; he was named National Sportscaster of the Year by the National Sportscasters and Sportswriters Association in 13 14 1977, and the organization inducted him into their hall of fame in 15 1994; he was a member of the American Sportscasters Association Hall of Fame as well, and he was also the recipient of the lifetime 16 17 achievement award from the National Academy of Television Arts and Sciences and the Pete Rozelle Radio-Television Award from the Pro 18 19 Football Hall of Fame; since 2006, the NFL has presented the annual Pat Summerall Award during Super Bowl weekend to a person whose 20 career has "demonstrated the character, integrity, and leadership 21 both on and off the job that the name Pat Summerall represents"; and 22 23 WHEREAS, A longtime resident of the Dallas-Fort Worth area, 24 Mr. Summerall was baptized at First Baptist Church in Euless and was a member of Prestonwood Baptist Church in Plano; in all his 25 26 endeavors, he enjoyed the support of his loving wife and best friend, Cheri Summerall; he was the father of 3 children, Susan, 27
