11 speech from Hardin-Simmons University and a master's degree in
12 those subjects from Bowling Green State University; he has taught
13 at Brownfield High School, Bee County College, and McLennan

15 of Texas at Austin and West Texas State University; in 2004, he
16 joined the Plains Independent School District, where he has taught
17 math as well as theater and speech; and

18 WHEREAS, Through his exceptional dedication, skill, and
19 creativity, Lou Lindsey has contributed immeasurably to the
20 tradition of excellence in theater arts at Plains High School, and
21 he may indeed take pride in his accomplishments; now, therefore, be
