- 6 Battalion, 36th Infantry, 1st Armored Division out of Fort Bliss,
- 7 First Lieutenant Landrum was one of five soldiers killed when their
- 8 vehicle was struck by an improvised explosive device in Maiwand,
- 9 Afghanistan; and
- 10 WHEREAS, Brandon Landrum was born in Lawton on December 5,
- 11 1986, to Jim and Jan Landrum; he graduated with honors from
- 12 MacArthur High School and enlisted in the U.S. Army in 2005; in
- 13 2008, he was deployed to Iraq, where he met another soldier, Miranda
- 14 Shae Hornbeck, and they returned home on leave to be married in
- 15 Lawton in May 2009; the couple were blessed with two children,
- 16 Gabriel and Blakely; and
- WHEREAS, After earning a bachelor's degree with honors from
- 18 Cameron University, this outstanding soldier earned a commission as
- 19 a second lieutenant and attended the Infantry Basic Officer Leaders
- 20 Course and Airborne School; in January 2012, he assumed the command
- 21 of a rifle platoon at Fort Bliss at the rank of first lieutenant,
- 22 and the following September he was selected to serve as
- 23 Reconnaissance Platoon leader; he was deployed to Afghanistan in
- 24 December 2012; and

- 1 WHEREAS, First Lieutenant Landrum's commendations include a 2 posthumous Bronze Star Medal and Purple Heart, as well as the Army
- 3 Commendation Medal, the Army Achievement Medal with one oak leaf
- 4 cluster, the Army Good Conduct Medal, the Global War on Terrorism
- 5 Service Medal, the National Defense Service Medal, the Iraq
- 6 Campaign Medal with a campaign star, the Afghanistan Campaign Medal
- 7 with a campaign star, a posthumous NATO Medal, and the Combat
- 8 Infantryman Badge; and
- 9 WHEREAS, Although the tragic death of this brave young man is
- 10 a sobering reminder of the cost of war, Brandon Landrum embodied the
- 11 highest ideals of the U.S. armed forces, and those who knew and
- 12 loved him will forever carry him close in their hearts; now,
