- 15 the Year in 2000; and
- WHEREAS, Mr. George was a city councilman in the late 1970s,
- 17 and he served as mayor pro tem and as a member of the Mayor's Drug
- 18 and Alcohol Task Force; one of the founders of Harmony Home
- 19 Children's Advocacy Center, a shelter for abused children, he also
- 20 served on the Pastoral Council at St. Elizabeth Ann Seton Catholic
- 21 Church, supported Odessa Catholic Charities, and dedicated time to
- 22 the local food bank's board of directors; and
- WHEREAS, A devoted husband and family man, Mr. George married
- 24 his high school sweetheart, the former Amanda Wallace, in 1971;

- 2 grandchildren, and Mr. George spent many happy hours attending
- 3 their recitals and sporting events or relaxing in the company of his

- 6 for hunting and fishing, and he also visited the Holy Land and
