RESOLUTION

1 WHEREAS, Blake Rocap is stepping down as legislative counsel

2 for NARAL Pro-Choice Texas, drawing to a close five years of

3 steadfast service in defense of the reproductive rights of Texas

4 women; and

5 WHEREAS, A statewide nonprofit and nonpartisan organization,

6 NARAL Pro-Choice Texas (NPCT) works to support and protect the

7 right of each woman to make personal and private decisions

8 regarding her reproductive choices and health; the group advocates

9 in behalf of pro-choice legislation and promotes access to a full

10 range of women's health care services; and

11 WHEREAS, Since assuming the role of legislative counsel in

12 2008, Mr. Rocap has coordinated NPCT's political outreach efforts,

13 in addition to serving as a de facto spokesperson to the media on

14 the group's stances and recommendations; a tireless champion of the

15 organization and its goals, he has attended and testified at a

16 multitude of committee hearings and met often with lawmakers to

17 discuss proposed legislation affecting women's health; and

18 WHEREAS, This lifelong Texan draws on a wealth of experience

19 in public interest law; he is a graduate of The University of Texas,

20 where he earned a bachelor's degree in American studies, and of

21 Texas Tech University, where he completed his doctor of

22 jurisprudence degree; while in law school, he was a founding board

23 member of the Student Public Interest Initiative, the social

24 director of the Board of Barristers, and a member of the curriculum

- 2 WHEREAS, His early career included summer clerkships with the
- 3 Texas Civil Rights Project, Jane's Due Process, and the United
- 4 States Equal Employment Opportunity Commission; after practicing
- 5 as a plaintiff's attorney in the areas of employment discrimination
- 6 and workplace safety, he accepted a position as general counsel to a
- 7 statewide political campaign, an experience that deepened his
- 8 understanding of Texas campaign finance and election law and that
- 9 cemented his interest in public policy; he additionally gained a
- 10 familiarity with the legislative process and parliamentary
- 11 procedure while serving as a committee clerk in the Texas House of
- 12 Representatives; and
- WHEREAS, Blake Rocap has worked tirelessly to defend the
- 14 cause of reproductive freedom in the Lone Star State, and in so
- 15 doing, he has earned the admiration and appreciation of countless
- 16 Texas women; now, therefore, be it
- 17 RESOLVED, That the House of Representatives of the 83rd Texas
- 18 Legislature hereby recognize Blake Rocap for his service to NARAL
- 19 Pro-Choice Texas and extend to him sincere best wishes for the
- 20 future; and, be it further
- 21 RESOLVED, That an official copy of this resolution be
- 22 prepared for Mr. Rocap as an expression of high regard by the Texas
- 23 House of Representatives.
