1 WHEREAS, Words cannot adequately convey the immense sorrow
2 felt at the loss of Thomas Lee Hultgren of New Braunfels, who passed
3 away on February 14, 2013, at the age of 49; and

4 WHEREAS, The son of Robert Karl Hultgren and Shirley Jean
5 Hultgren, "Tommy" Hultgren was born in Alamogordo, New Mexico, on
6 March 30, 1963; at the age of eight, he moved with his family to San
7 Antonio, where he grew up and established himself as a
8 tried-and-true Texan; and

9 WHEREAS, Mr. Hultgren, after attending North Texas State
10 University, developed a passion for photography while working for
11 the *Denton Record-Chronicle*; his gift for capturing people and
12 places was carried on throughout his life, with stints at the
13 *Kerrville Daily Times* and the *San Antonio Light* and eventually as a
14 freelance photographer for The Associated Press, the former
15 Southwestern Bell telephone company, and H-E-B; and

16 WHEREAS, Mr. Hultgren's photographs were beyond merely
17 artistic in nature; each snapshot embodied his perspective on life,
18 effortlessly capturing what seemed commonplace and turning it into
19 something special; his easygoing personality, paired with a
20 generous heart, helped people feel comfortable and at ease and
21 aided him in the preservation of countless perfect moments on film;

23 WHEREAS, He touched innumerable lives through his work and
24 impressed all those who came to know him with his concern for

1 others and his optimism; moreover, his love for others was also
2 evident from the great devotion he showed to his wife and children;

4 WHEREAS, While his life ended far too soon, Thomas Hultgren
5 brought abundant joy to his loved ones, and his legacy inspires all
6 who presume themselves ordinary to carry on in extraordinary
7 fashion; now, therefore, be it

8 RESOLVED, That the House of Representatives of the 83rd Texas
9 Legislature hereby pay tribute to the life of Thomas Lee Hultgren
10 and extend deepest sympathy to the members of his family: to his
11 wife, Julie Jerome; to his mother, Shirley Hultgren; to his four
12 children: sons, Ethan and Ansen Hultgren, stepson, Teddy Crimmins,
13 and stepdaughter, Addie Crimmins; to his sisters, Susan Reyes and
14 her husband, Jesse, and Jo Anne Hultgren; to his brothers, Robert
15 Hultgren and his wife, Joyce, and Mike Hultgren and his wife,
