- 1 WHEREAS, The passing of Brian H. Eckler of San Antonio on
- 2 April 23, 2013, at the age of 69, has brought a great loss to his
- 3 family, his friends, and the community he served with such

- 5 WHEREAS, Born September 15, 1943, in Johnstown, New York,
- 6 Brian Eckler was the son of George and Helen Eckler; he graduated
- 7 from Johnstown High School and embarked on a long and distinguished
- 8 career in the United States Air Force; first posted to Norfolk,
- 9 England, he went on to serve in Diyarbakir, Turkey, and at the
- 10 Presidential Aeronautical Station on Andrews Air Force Base in
- 11 Maryland; and
- 12 WHEREAS, Mr. Eckler met his future wife, Lora Devlon
- 13 Kartchner, while stationed in the Washington, D.C., area, and after
- 14 their marriage, he was transferred to Goodfellow AFB in San Angelo
- 15 to prepare for entry into the USAF Security Service; he served at
- 16 Karamursel Common Defense Installation, Turkey, and then with the
- 17 6970 Electronic Security Group at the National Security Agency in
- 18 Maryland; further training took him to Corry Naval Station in
- 19 Pensacola, Florida, where he developed an enduring fondness for
- 20 pink flamingos; and
- 21 WHEREAS, During a posting with the 6920 ESG at Misawa AFB in
- 22 Japan, Mr. Eckler joined his wife in volunteering to instruct local
- 23 teachers in conversational English and American customs; his
- 24 subsequent adventures included two stints with the Air Force

- 1 Cryptologic Support Center at Kelly AFB and a remote, unaccompanied
- 2 tour to 2146th Com Group, Osan Air Base, in South Korea, which
- 3 enabled him to visit every mountaintop in the country at least once;
- 4 he finally retired at the rank of master sergeant in 1987, long
- 5 after he had reached his eligibility as a disabled veteran; still
- 6 not quite ready to relax, he joined an elite team of security
- 7 experts dispatched to the new embassy in Moscow, Russia, on a
- 8 mission that required improvising outdoor inspection procedures in
- 9 temperatures that plunged to 40 below zero; and
- 10 WHEREAS, Once settled in San Antonio, Mr. Eckler became very
- 11 active in his neighborhood association and volunteered tirelessly
- 12 alongside his wife at the local library and elementary school, as
- 13 well as at a host of community events; he was always ready to lend a
- 14 hand when needed, and he enjoyed caring for feral cats and kittens,
- in addition to his own cat, Ms. Bootsie; he worked some night shifts
- 16 in security, and in his spare time, he was a voracious reader and
- 17 researcher; he liked cooking elaborate meals, discovering new food,
- 18 and driving around in his vintage Volkswagen bus with its
- 19 ever-changing bumper stickers; having grown a snowy beard to
- 20 complement his mustache, he was often mistaken for Santa by
- 21 delighted children, although his wardrobe of colorful T-shirts
- 22 would never have passed muster at the North Pole; and
- WHEREAS, Brian Eckler will be deeply missed, and those who
- 24 were fortunate enough to know him will forever remember their
- 25 favorite explorer, who never stopped learning and lived life to the
- 26 fullest for all of his days; now, therefore, be it
