Suspending limitations on conference committee jurisdiction, H.B. No. 3459 (Eiland/L. Taylor)

RESOLUTION

- 1 BE IT RESOLVED by the House of Representatives of the State of
- 2 Texas, 83rd Legislature, Regular Session, 2013, That House Rule 13,
- 3 Section 9(a), be suspended in part as provided by House Rule 13,
- 4 Section 9(f), to enable the conference committee appointed to
- 5 resolve the differences on House Bill 3459 (access to and
- 6 protection of certain coastal areas) to consider and take action on
- 7 the following matter:
- 8 House Rule 13, Section 9(a)(4), is suspended to permit the
- 9 committee to add text on a matter which is not included in either
- 10 the house or senate version of the bill by adding the following new
- 11 SECTIONS to the bill:
- 12 SECTION 7. The legislature finds that:
- 13 (1) the Galveston-Houston region and the region's
- 14 economic and strategic infrastructure are at risk due to exposure
- 15 to potential catastrophic storm surge;
- 16 (2) to protect the Galveston-Houston region's five
- 17 million residents and the region's economic and strategic
- 18 infrastructure, various federal, state, and local entities, led by
- 19 Texas A&M University at Galveston, are studying and developing
- 20 conceptual designs for a coastal barrier to protect the region from
- 21 hurricane-induced storm surge;
- 22 (3) as currently envisioned, a project referred to as
- 23 the "Ike Dike" would extend the protection afforded by the
- 24 Galveston Seawall along the rest of Galveston Island and along the

- 1 Bolivar Peninsula by creating a 17-foot-high revetment (sand
- 2 covered dune with hardened cores) near the beach or by raising
- 3 coastal highways;
- 4 (4) the addition of floodgates at Bolivar Roads, at
- 5 the entrance to the Houston, Texas City, and Galveston Ship
- 6 Channels, and at San Luis Pass would complete a coastal spine that
- 7 would provide a barrier against all gulf surges into Galveston Bay;
- 8 (5) a research team is being led by Texas A&M
- 9 University at Galveston through its Center for Texas Beaches and
- 10 Shores using strong partnerships with the U.S. Department of
- 11 Homeland Security Coastal Hazards Center of Excellence at Jackson
- 12 State University, the Netherlands' Delft University of Technology's
- 13 Department of Hydraulic Engineering, and the University of Houston
- 14 C. T. Bauer College of Business's Institute for Regional
- 15 Forecasting;
- 16 (6) the General Land Office is a sponsor of and
- 17 nonfederal partner for a United States Army Corps of Engineers
- 18 study of the upper Texas coast to develop a list of specific
- 19 recommended projects that may become eligible for federal
- 20 appropriations;
- 21 (7) the United States Army Corps of Engineers study,
- 22 which encompasses Brazoria, Galveston, Harris, Chambers,
- 23 Jefferson, and Orange Counties, includes the coastal barrier/"Ike
- 24 Dike" concept; and
- 25 (8) as a result of the studies and recommendations
- 26 described by this section, the legislature may need to enact or
- 27 amend state law to accommodate the building of a coastal barrier to

- 1 protect the region from hurricane-induced storm surge.
- 2 SECTION 8. (a) The legislature shall establish a joint
- 3 interim committee to conduct a study of:
- 4 (1) the effectiveness of the implementation of the
- 5 changes in law made by this Act to Chapter 61, Natural Resources
- 6 Code; and
- 7 (2) the feasibility and desirability of:
- 8 (A) creating and maintaining a coastal barrier
- 9 system in this state that includes a series of gates and barriers to
- 10 prevent storm surge damage to gulf beaches or coastal ports,
- 11 industry, or property; and
- 12 (B) authorizing coastal property owners to grant
- 13 easements to governmental entities to construct and maintain
- 14 stabilized dunes in connection with or separately from the system.
- 15 (b) The committee is composed of:
- 16 (1) the members of the standing committee of the
- 17 senate that has primary jurisdiction over natural resources;
- 18 (2) the members of the standing committee of the house
- 19 of representatives that has primary jurisdiction over land and
- 20 resource management;
- 21 (3) two members of the senate appointed by the
- 22 lieutenant governor, each of whom represents a district in a county
- 23 that borders the Gulf of Mexico; and
- 24 (4) two members of the house of representatives
- 25 appointed by the speaker of the house of representatives, each of
- 26 whom represents a district in a county that borders the Gulf of
- 27 Mexico.

- 1 (c) The lieutenant governor and the speaker of the house of
- 2 representatives shall jointly designate a chair or, alternatively,
- 3 designate two co-chairs from among the committee membership.
- 4 (d) The committee may adopt rules necessary to carry out the
- 5 committee's duties under this section.
- 6 (e) Not later than December 1, 2014, the committee shall
- 7 report to the governor and the legislature the findings of the study
- 8 and any recommendations developed by the committee under this
- 9 section.
- 10 Explanation: This addition is necessary to provide for a
- 11 study determining the effectiveness of the implementation of the
- 12 changes in law made by the bill to Chapter 61, Natural Resources
- 13 Code, and determining the feasibility and desirability of certain
- 14 coastal protection measures.
