- 15 Facilities Commission, this Act controls without regard to the
- 16 relative dates of enactment.
- 17 Explanation: This addition is necessary to ensure that the
- 18 sunset review date for the Texas Facilities Commission in the bill
- 19 controls over any other bill amending that date.
- 20 (2) House Rule 13, Section 9(a)(4), is suspended to permit

- (c) This section takes effect only if the 83rd Legislature,
